1:30 – 2:00 Set up room for Encampment

2:00 – 5:00 Business Meeting. We will be recognizing our Past Department Commanders and conducting the business of the Department. This will include reports from the camps and Department officers, action on several proposed bylaws amendments, and the election and installation of officers for the next year.

All members of the Department are encouraged to attend the Encampment. If you are planning to attend, you need to notify your Department Commander or Secretary by April 14, both as to attending and whether or not you plan to eat the noon meal with us.

PAST DEPARTMENT COMMANDER

This year, at our Department Encampment, we will be honoring the past commanders of our Department. Being a Past Department Commander is more than a statement of past service, it is one of the Honors of the Order which is awarded to a brother who has satisfactorily served as a department commander.

The regulations of the Order state: “Brothers who have served a full term as Department Commander or who have been elected to fill a vacancy and who served to the end of that term may wear the Past Department Commander badge and are entitled to use the suffix P.D.C. in conjunction with their name.” They attend the Department of Kansas encampments as voting members, and do not count against the maximum delegate strength for a camp. Likewise, they attend the National Encampment with “automatic” voting rights and do not count against the maximum delegate strength for the Department.

Mine Creek Bridge Project

In April 2005, members of the Department of Kansas constructed a twenty-three foot bridge over a tributary of Mine Creek. This structure enabled the battlefield to designate a circuitous route for a walking trail. The trail allows battlefield visitors to see important sites necessary to understand the battle. It also allows small vehicles to traverse the field for maintenance and for the transporting of disabled persons. A tour brochure has been published and is available at the Visitors Center for persons interested in the battle. The Kansas Department, through many means, raised the funds for the purchase of the bridge, which was paid in full this month. Thanks go to Jim and Barbara Knopke for their “cookie jars” which went a long way to raising the final funds to pay the cost of the bridge. Also, a special thanks goes to all brothers and camps who reached into their pockets to help pay for the bridge.

Soon, a plaque will be placed beside the bridge describing the efforts of the members of the Kansas Department. At the 2005 encampment, it was voted to name the bridge in honor of Lt. Colonel Frederick Benteen, whose forces successfully attacked rebel lines in the area near the bridge.

I hope members will take the opportunity to visit the battlefield and take pride in the bridge that is so important to the interpretation of the battle.

Graves Registration

Why Graves Registration?

Why graves registration? Way back when, even before I was in the Army, there was Graves Registration under the Quartermaster Department of the Army. During the Mexican War, Quartermaster Officers were with the American Forces in Mexico. Their duty was to collect the remains of Americans, bury them in temporary cemeteries, and later make arrangements for the remains to be returned to the United States. Of course this didn't always happen.

During the Civil War, this same Graves Registration was swamped by the number of remains and the shifting battle lines from battle to battles. Union troops would retake grounds that they had taken before, only to find the unburied remains of fallen comrades who had died during the previous battle. Later, due to public outcry, Graves Registration came into its own.

At the end of the Civil War and after the National Cemeteries were established, a major effort was made to gather all of the remains and move them to appropriate cemeteries. Of course there were many unknowns, and they are unknown to this day.

Next to the Lee House at the Arlington National Cemetery close to Washington, DC, is a monument to the unknown dead. It is a monument, but also a mausoleum, for it contains the remains of over 700 soldiers of both the North and the South. This is the final resting place of the remains that were found on various battlefields. It could not be determined whether they were Union or Confederate.

Now, what does this have to do our SUVCW Graves Registration? These soldiers, sailors and marines deserve to be remembered. They deserve an appropriate marker showing their service to our country. That is where our obligation continues.

Carol Dark Ayres, in her book, Lincoln and Kansas writes:

"On his journey from Illinois to his March 4th Washington inaugural, Lincoln stopped in Philadelphia, PA, on Feb. 22, 1861, to raise a new flag over Independence Hall. The flag bore, for the first time, the 34th star — Kansas. He made these remarks:

"Fellow Citizens: -- I am invited and called before you to participate in raising above Independence Hall the flag of our country, with an additional star upon it. (Cheers) ... I propose to say that when that flag was originally raised here it had but thirteen stars. I wish to call your attention to the fact, that, under the blessing of God, each additional star added to that flag has given additional prosperity and happiness to this country until it has advanced to its present condition; and its welfare in the future, as well as in the past, is in your hands. (Cheers) Cultivating the spirit that animated our fathers, who gave renown and celebrity to this Hall, cherishing that fraternal feeling which has so long characterized us as a nation, excluding passion, ill-

temper and precipitate action on all occasions, I think we may promise ourselves that not only the new star placed upon the flag shall be permitted to remain there to our permanent prosperity for years to come, but additional ones shall from time to time be placed there, until we shall number ... five hundred millions of happy and prosperous people. (Great Applause) ..."



Chaplain

As I said in the last few articles about Civil War Chaplains, they served many roles, including being spiritual leaders, postmen, bankers, doctor, and many other things to keep the morals and the morale of the soldiers at a high level. The following article shows more of how chaplains worked to help regiments accomplish their tasks and tells of the dangers they faced. I am relating as much as I remember about the life of one of Kansas's own chaplains.

The Guns and the Gospel

This is the title of an autobiography of Hugh D. Fisher, a Regimental Chaplain for Jim Lane. In the book he tells about the many experiences he had as he became a preacher in different areas of the U. S. prior to the Civil War. When the troubles started in Kansas he joined the Jayhawkers. He relates how he and fourteen men were ordered by Lane to escort several hundred contraband slaves to safety in Kansas. These slaves had flocked to Lane's Brigade after the Osceola, Missouri raid. Once he escorted the slaves across the Kansas border, he told them "in the name of the Constitution of the United States, the Declaration of Independence, and by the authority of General James H. Lane, I proclaim that you are forever free".

In regard to the danger of being a Chaplain and not always having the protection of the army. He relates how his wife saved his life from Quantrill and his men during the Lawrence raid. He hid in the basement and she challenged the ruffians and out-foxed them to protect him. After the raiders set the house on fire she and a neighbor fought it in the area where Hugh was hiding. This was done long enough to allow him to get out of the house after most of the men left. He hid under a rug outside and stayed there until all of the raiders left Lawrence.

So we see that it was not easy being a Civil War Chaplain. The soldiers were not the only ones with their lives in danger while trying to save the union of the states.


Commander Knopke has worked hard to ensure an enjoyable and informative encampment. I look forward to seeing everyone at the program and meeting.
