#### SONS OF UNION VETERANS OF THE CIVIL WAR

#### April 25, 2009 Olathe, Kansas

#### **ENCAMPMENT OPENING**

- 1. As required by Chapter II, Article III, Section 1 of the Regulations of the Sons of Union Veterans of the Civil War and by Article VI, Bylaws of the Department of Kansas, SUVCW, the Thirteenth Annual Encampment of the Department of Kansas, was held on April 25, 2009, at American Legion Post 153, Olathe, Kansas.
- 2. The Encampment was called to order at 10:45 AM by Department Commander Craig A. Sundell. At that time, the Past Department Commanders were announced and filed into the room. A vacant chair remained in memory of PDC Kenneth D. Strader.
- 3. The opening ceremony was conducted per the Rituals and Ceremonies of the Order.
- 4. The roll call of officers was conducted with the following officers present or accounted for:

- 5. The opening of the Encampment concluded with Chaplain's prayer, followed by the Encampment attendees singing the "Battle Hymn of the Republic."
- 6. The Encampment received visiting National Council of Administration Member Robert Petrovic, Department of Missouri, representing Commander in Chief David V. Medert, PDC, Department of Ohio. PDC Petrovic presented greetings on behalf of the Commander in Chief.
- 7. Commander Sundell informed the Encampment of "housekeeping rules" to be used during the meeting.

#### **CORRESPONDENCE**

- 11. Reading of incoming correspondence was conducted by the Department Secretary.
  - a. One letter was from the National Organization, SUVCW, concerning required action by the Department on ratification of an amendment to the Constitution of the Order allowing the Commander-in-Chief to hold implementation of a change to the National Regulations in abeyance if he determines it to be in conflict with the Federal Charter or the Constitution of the SUVCW. Commander Sundell ruled the amendment would be addressed under "new business."
  - b. The other correspondence concerned a nominations National Junior Vice Commander in Chief and National Council of Administration. The correspondence was summarized and made available to those desiring to read the complete texts.
- 12. There being no unfinished business, Commander Sundell called for committee reports to be presented.

#### **COMMITTEE REPORTS**

13. The following committee reports were presented and accepted by the Encampment as written:

14. Commander Sundell declared that the Bylaws Committee report was to be held until "new business" and the Nominating Committee report was to be held until the start of the nomination process.

#### DEPARTMENT COUNCIL REPORT

- 15. PDC Thomas E. Schmidt, Department Council member, presented a report as to the satisfactory state of the funds of the Department. [Page C-3]
- 16. As it was now 11:45 AM and approaching the designated lunch time. Commander Sundell directed the Chaplain to close the Bible. He then declared a recess until 1 PM, and also requested that the Department Officers, Past Department Commanders, and National Representative Petrovic would accompany him on a visitation to the Department of Kansas LGAR Encampment in the other room. This visitation would occur prior to the Encampment resuming.

#### **NEW BUSINESS**

- 17. At 1:05 PM, the Encampment was called back into session by Commander Sundell, with the Chaplain re-opening the Bible.
- 18. The proposed amendment to the National Constitution, concerning the authority of the Commander-in-Chief to hold an approved change to the National Regulations when in conflict with the Federal Charter or National Constitution, was approved by vote of the Encampment. The Secretary was directed to notify the National Secretary of the results.
- 19. Commander Sundell called upon PDC Russ, as Chairman of the Bylaws Committee, to present the amendments which had been presented to the committee during the year. PDC Russ presented each of the amendments (2009-01 through 2009-04) [Page D-1] to the Encampment, at which time they were voted on and approved.
- 20. Commander Sundell noted that no proposed amendments had been referred to the Encampment Bylaws Committee.
- 21. Commander Sundell requested to know who planned to attend the 2009 National Encampment as "automatic" attendees. Commander Sundell (Camp 4) stated he would be attending (as PDC); along with PDC Thomas E. Schmidt, Camp 1(as PDC); PDC Roy A. Lafferty, Camp 4 (as PDC); PDC Alan L. Russ, Camp 16 (as PDC); PDC James R. Knopke; Camp 5 (as PDC); PDC Dean K. Speaks, Camp 1 (as PDC); and the new Department Commander, in that capacity.
- 22. Commander Sundell stated that the Department of Kansas was entitled to seven delegates to the National Encampment. He then asked the Encampment who else was desiring to attend the National Encampment as a delegate. PCC Matthew G. Toll, Camp 5; Robert L. Wandel, Camp 4; Brian R. Van Schmus, Camp 4; and S. Todd Meeks, Camp 1, stated their intentions to attend. PDC Durbin moved that the brothers attending without "automatic" status should be declared delegates to the Encampment. Motion was seconded and carried.
- 23. Commander Sundell recognized PDC Russ, who moved that all brothers of the Department, who are in good standing and do not hold another qualifying status to attend the National Encampment shall be declared as Alternate Delegates. Motion passed.
- 24. Commander Sundell announced that, per the Department Bylaws, the 14<sup>th</sup> Annual Encampment of the Department of Kansas would be on April 24, 2010. Also, per the bylaws, the camp next in line to host the Encampment is Mine Creek Camp 6, Pleasanton. Commander Sundell asked if anyone from Mine Creek Camp 6 was present to accept the hosting of the 14th Annual Encampment. There being no one from Mine Creek Camp 6 present, Commander Sundell moved to the next camp in line, Old Abe Camp 16, Topeka. He asked if anyone from Old Abe Camp 16 was present to accept the hosting of the 14th Annual Encampment. Old Abe Camp 16 passed on accepting the hosting of the 14<sup>th</sup> Annual Encampment. Commander Sundell then moved to the next camp in line, Corp. Patrick Coyne Camp 1, Wichita. He asked Camp Commander Meeks if Corp. Patrick Coyne Camp 1 would accept the hosting of the 14th Annual Encampment. Camp Commander Meeks replied that the Wichita camp will be the host camp.
- 25. PDC Dean K. Speaks asked to approach the podium to speak. He then asked the Encampment to declare Brother Robert Petrovic to be an "Honorary Kansan" in recognition of the number of Department of Kansas Encampments he has attended, along with the assistance of Brother Petrovic to the Department in preparing for the 2010 National Encampment. This was heartily accepted by the Encampment.

- 26. PDC Speaks then challenged the Department to help raise money for hosting the 2010 National Encampment in Overland Park. He offered that he would match, one for one, each dollar raised between this Department Encampment and the Fall Council Meeting (October 10, 2009), up to a maximum of \$2,500. To start off the fund-raising, he presented the Department with a check for \$500.00. PDC Speaks next challenged the Department to increase its strength by fifty percent between now and the next Department Encampment (April 24, 2010). Based upon the Department strength as of March 31, 2009, this would be an increase of 74 brothers. He stated that all categories (members, associates, junior members, and junior associates) would count toward reaching this goal. If the goal is reached, PDC Speaks stated he would donate \$1,000 to the Department. Commander Sundell expressed his appreciation, on behalf of the Department, for PDC Speaks' challenge and the potential good it would do for the Department.
- 27. Commander Sundell recognized PDC Thomas E. Schmidt. PDC Schmidt challenged all brothers and camps to raise funds for the 2010 National Encampment in order to maximize Brother Speaks' contribution.
- 28. There being no more new business to come before the Encampment, Commander Sundell proceeded with the nominations and election of officers.

#### NOMINATIONS AND ELECTION OF OFFICERS

- 29. At this time, Commander Sundell asked the Nominating Committee to present their report. PDC Alan L. Russ presented the report. [Page C-3]
- 30. Commander Sundell then placed the recommendations of the Nominating Committee into nomination for their respective positions, and officially discharged the Nominating Committee with a "Thank you" from the Department.
- 31. Commander Sundell then opened the floor to other nominations. None were submitted.
- 32. There being no more new business, the Encampment proceeded to the election of officers. The Department Secretary read the names of those recommended by the Nominating Committee, said report having been accepted by the Encampment. Those brothers were then submitted as candidates for the offices indicated:

- 33. Commander Sundell asked for additional nominations from the floor of the Encampment. No further nominations were submitted and nominations were closed.
- 34. PDC Frank Bergquist moved the nominees be elected by acclamation of the Encampment. Motion was seconded and carried.
- 35. Commander Sundell requested a motion from the floor to recognize Franklin Camp 5 for all of its efforts in hosting the Encampment. PDC Randy Durbin moved for the request. The motion was seconded and carried.
- 36. Commander Sundell requested a motion from the floor to recognize American Legion Post 153 for providing the meeting facilities. PCC Matt Toll moved for the request. The motion was seconded and carried.
- 37. At this time, Commander Sundell presented the following awards to the indicated recipients:

- 42. The Department flag was then transferred from outgoing Commander Sundell to incoming Commander Converse.
- 43. Commander Converse presented PDC Craig A. Sundell with a certificate of recognition for his service as the Eleventh Department of Kansas Commander and presented him with the Past Department Commander badge.

#### **CLOSING**

44. Commander Converse then proceeded to close the Encampment, as per the Ritual of the Order. The Encampment was declared closed at 2:15 PM.

I hope it will please the Department Commander that I have combined my three reports. From November on I have had family matters out of state to deal with, and it has restricted my ability to work on SUVCW affairs. I regret this, but it has been unavoidable.

As the Department Historian I have responded to a few inquiries that have come my way. While most are about soldiers who may have lived in Kansas, some have been in regards to GAR Post Records and who may have them.

In this respect it's very convenient having the KSHS Archives a short walk from my office, but it has also been useful having some knowledge of historical museums throughout the state.

The Last Soldier Project is an area where progress needs to be stepped up a bit, as the Department in the past has discussed using this information during the Sesquicentennial, perhaps producing a book. I believe we are still 13 counties short of having a Last Soldier for each county, and there are others that need to firmed up by further research.

The search for GAR Records continues, although finding out about records in the 105 counties has come about by some of the inquiries to the Historian. This needs a more thorough search of museums and libraries across the state, and I would ask my brothers if they know of the location of GAR records, that they forward that information to me.

A major disappointment of the year is that I expected to have a proposal at this encampment regarding archival material that should be kept by the camps and the Department, so that copies can be turned over the archives of the Kansas Historical Society—and local historical societies—for safe keeping. I swear this will be done this coming

In spite of all this, I'm going to ask for assistance in identifying and locating GAR plots in local cemeteries, and identifying the posts that purchased the plots. For instance, in Topeka we have five GAR plots in four cemeteries, purchased by four posts. My thought with this is that a listing of GAR plots may have value with genealogists, and may not be entirely incompatible with the GAR Memorials and Monuments Project. Submitted in F.C. & L,

#### ATTACHMENT D – PROPOSED AMENDMENTS TO

#### AMENDMENT 2008-01

**SUMMARY:** This amendment establishes specific dates for Department Council Meetings and the Winter Training sessions to be held.

**DISCUSSION:** By establishing specific dates for these events, camps and Department Officers will be able to plan for participation in these events on a long-term time frame. The amendment also clarifies the purpose for the meeting, voting and non-voting members, and the status of other attendees.

#### **ARTICLE VI – MEETINGS**

- **Section H. FALL COUNCIL MEETING.** The officers of the Department shall conduct the "Fall Council Meeting" each year on the **third Saturday of October**. The location and time for the meeting shall be determined by the Department Commander.
- (1) **Purpose.** The Fall Council Meeting shall be for the purpose conducting the routine business of the Department, to include approving expenditures, policies, and procedures. The Department Council will not take actions which are reserved for the Department Encampment. Likewise, any action of the Department Council may be overruled by action of the next Department Encampment.
- (2) Voting Members. The elected offices of the Department and the immediate Past Department Commander are the voting members of the Department Council.

#### (3) Non-voting Members.

- (a) All appointed Department Officers are members of the Council, without vote, and should be in attendance.
- (b) All brothers of the Department holding the honor of Past Department Commander are members without vote, and, as such, encouraged to attend the meeting.

#### (4) Other Attendees.

- (a) Camp Commanders, or their designated representative, should attend. They should be prepared to report on the activities of their camp. This provides an opportunity for communication between the Department Officers and the camps. Camp Commanders or representatives are attendees without membership on the Council and without vote.
- (b) All brothers of the Department are permitted and encouraged to attend the meeting without voice or vote. Any attendee may request of the Department Commander to present an item to the meeting or to provide discussion or comments on an item being discussed at the meeting. It shall be the decision of the Department Commander as to whether this shall be permitted.
- **Section I. WINTER TRAINING SESSION.** The Winter Training Session for the Department shall be conducted on the **second Saturday of January**. The location and time for the meeting shall be determined by the Department Commander. The purpose of the Winter Training Session is to provide updated information and training to the elected officers of the Camps. This meeting is scheduled to have the greatest impact on the newly elected camp officers.
  - (1) Trainers/Presenters will be the elected Department officers or designee.
- (2) Attendees should be the Camp Commanders, Camp Senior Vice Commanders, Camp Junior Vice Commanders, and Camp Secretaries/Treasurers.
- **Section J. SPRING COUNCIL MEETING.** The officers of the Department shall conduct the "Spring Council Meeting" each year on the **second Saturday of March**. The location and time for the meeting shall be determined by the Department Commander, with preference given to locating it at the camp which will be the host camp for the upcoming Department Encampment. The attendees, purpose, and limitations are as described for the Fall Council Meeting, above.

#### AMENDMENT 2008-02

**SUMMARY:** This amendment adds the requirement for the Department Flag to be displayed at all meetings of the Department.

**DISCUSSION:** The Department, having acquired a Department Flag, should proudly include it at its meetings, as is required of the Department Charter and United States Flag.

#### **Article VI: MEETINGS**

**Section D.** All meetings of the Department shall have a United States Flag, the Department Flag, and the Department Charter displayed.

#### **AMENDMENT 2008-03**

**SUMMARY:** This amendment removes the requirement that the incoming Department Commander must appoint a Guide, Color Bearer, and Guard. Instead, it allows these positions to be filled pro tempore when they are needed. **DISCUSSION:** Current bylaws require the incoming Department Commander to appoint these positions. Since the following Department encampment will usually be held in another city the next year, this amendment allows the Department Commander to appoint these positions for that encampment from brothers who will be able to attend.

#### **Article VII: OFFICERS**

**Section A.** The Officers of the Department shall be the Department Commander, Senior Vice Department Commander, Junior Vice Department Commander, three brothers of the Department Council, Department Patriotic Instructor, Department Chaplain, Department Secretary/Treasurer, Department Historian, Department Counselor, Department Graves Registration Officer, and Department Civil War Memorials Officer, Guide, Color Bearer, and Guard. The incoming Department Commander may delay appointing brothers to the offices of Guide, Color Bearer, and Guard until the next Department Encampment, at which time he will appoint them *pro tempore*.

#### **AMENDMENT 2008-04**

**SUMMARY:** This amendment further subdivides Section B by adding a title to the section, numbering the two existing subparagraphs as (1) and (2) and adding subparagraph (3). New subsection (3) adds additional requirements that a brother must be present at the Department Encampment in order to be nominated for the positions of Senior Vice Commander and Junior Vice Commander. This subsection includes provisions and procedures to allow the Department Encampment to grant an exception to the brother needing to be present. Additionally, it requires that a brother must be, or have been, a Camp Commander prior to being elected as Senior Vice Commander and Junior Vice Commander.

**DISCUSSION:** Current bylaws require that a brother must be present and entitled to vote at the encampment in order to be elected to the position of Department Commander. This is a requirement in the National Regulations. This amendment places the attendance requirement on candidates for SVC and JVC. It also provides that extenuating circumstances may cause the Encampment to desire to allow an exception. No exceptions are allowed for election to the office of Department Commander, as this would be in conflict with National Regulations. As to requiring a brother to have been a Camp Commander prior to being elected to the offices of SVC or JVC, this ensures their qualification to become Department Commander, either to fill a vacancy in that office, or to move up in progression.

#### **Article VII: OFFICERS**

#### Section B. Election of Officers, Delegates, and Alternates.

- (1) The Department Commander, Senior Vice Department Commander, Junior Vice Department Commander, Department Council, Department Secretary/ Treasurer, Delegates and Alternates to the National Encampment shall be elected at the annual encampment by a roll-call of Camps in numerical order, and a majority of all the votes cast shall be necessary for a choice, except in the case of the Department Council, Delegates and Alternates, wherein a plurality vote shall elect. If there is but one nominee for an office the Department may elect by viva voce vote.
- (2) Provided, that no brother shall be eligible for election to the office of Department Commander unless he has served as a Camp Commander. No brother shall be eligible for election to the office of Department Commander who is not present and entitled to vote at the Department Encampment.
- (3) No brother shall be eligible for election to the Department offices of Senior Vice Commander or Junior Vice Commander unless he has served, or is currently serving, as a Camp Commander. No brother shall be eligible to be nominated for election to the office of Senior Vice Commander or Junior Vice Commander who is not present and entitled to vote at the Department Encampment. In the case of a nominee for Senior Vice Commander or Junior Vice Commander, the nomination of a brother to these offices, and the election thereto, may occur in his absence provided that:

- (a) A motion to nominate in his absence is made and approved by two-thirds(2/3)of the voting membership present at the Department Encampment; and
- (b) The brother to be nominated has submitted, in writing, a statement, that, if he is elected to the position for which he is to be nominated, he will provide satisfactory service during his term of office; and
- (c) The brother to be nominated has stated in writing that he knows of no reason to prevent him from performing his duties during the coming year, and that he will attend the following Department Encampment.

#### **AMENDMENT 2008-05**

**SUMMARY:** This amendment establishes a term of office for Secretary/Treasurer as being a period of three years. **DISCUSSION:** National Regulations require all Department officers to be elected for a period of one, except that a Department may fix the term for the office of Secretary, Treasurer, or Secretary/Treasurer. The regulations also allow that the terms for Council members may be set for a period of two years. This amendment only addresses the office of Secretary/Treasurer. As this position is critical to the continuity of the Department, a three year term brings stability to the position, in that when a brother accepts the position, he will know how long he is expected to serve.

#### **Article VII: OFFICERS**

**Section D.** The term of all elective and appointed officers, except the office of Secretary/Treasurer, shall be for one year. The term of office for Secretary/Treasurer shall be for three (3) years, commencing with the 2008 term. [NOTE: In 2008, the sitting Secretary/Treasurer shall be elected to a one-year term, with the term of office being automatically extended to three (3) years from the date last elected upon approval of this amendment by the Commander-in-Chief.]

#### **AMENDMENT 2008-06**

**SUMMARY:** This amendment places the Mine Creek Battlefield Committee as a Standing Committee within the Department Bylaws.

**DISCUSSION:** The Tenth Department Encampment established the committee as a permanent committee. This amendment places that committee within the bylaws, where permanent committees should be contained.

#### **Article X: COMMITTEES**

**Section B.** (*Deleted*) Mine Creek Battlefield Committee. The Mine Creek Battlefield Committee, established by the Tenth Annual Department Encampment, shall be responsible for working with both the Mine Creek Battlefield Foundation and the Kansas State Historical Society for the purpose of bettering the Mine Creek Battlefield. Such committee shall keep the Department Commander informed of its activities. The chairman of the committee shall report annually to the Department Encampment. The committee shall consist of five brothers appointed by the Department Commander, one of whom shall be a brother with Mine Creek Camp 6.

#### **AMENDMENT 2008-07**

**SUMMARY:** This amendment places currently awarded Department awards into the Department Bylaws. **DISCUSSION:** Placing these awards into the Department Bylaws will ensure the awards and their original intent is

not lost. This gives them permanent status and ensure that consistent criteria will be maintained for awarding them.

#### Article XII. DEPARTMENT AWARDS

**Section C.** The following awards, having been well established within the Department of Kansas by precedent, are established as permanent awards of the Department. These awards, and their criteria, are as follows:

- (1) **CORPORAL LEONIDUS B. DAVIS AWARD FOR RECRUITER OF THE YEAR.** This award may be presented by the Department Commander to the brother who has recruited the most new brothers (Members, Associates, and Juniors) since the previous Department Encampment. The determination of which brother is to receive credit for a new brother is based upon the name entered on the application for membership as "Recommended by SUVCW Brother." Applications received from the National Junior Vice Commander-in-Chief are not considered when determining the number of "recruits." The Department Commander may determine not to present the award any year he feels no one has recruited enough brothers to set him apart in this regard.
- (2) **CAPTAIN PATRICK H.CONEY AWARD FOR BROTHER OF THE YEAR.** This award is presented by the Department Commander to the brother whom the Department Commander has determined to have

performed significant service to a camp or the Department within the past year. The Department Commander shall seek recommendations from the various Camp Commanders for this award.

- (3) **LEANDER STILLWELL OUTSTANDING ACHIEVEMENT AWARD.** This award may be presented by the Department Commander to the brother who has performed significant service to the Department of Kansas or the organization as a whole over an extended period of time. The Department Commander may seek recommendations from Camp Commanders, Department Officers, Past Department Commanders, and others. This award is neither required nor expected to be awarded each year.
- (4) **WILLIAM W. NIXON AWARD FOR CAMP OF THE YEAR.** This award is presented by the Department Commander to the camp within the Department which demonstrated the greatest degree of support to the goals and ideals of the Sons of Union Veterans of the Civil War in such areas as community involvement, memorial ceremonies, public education, conduct of camp meetings, and such. The Department Commander shall seek recommendations from the various Camp Commanders for this award.
