In a period of two day in March of 2010, Kansas lost two long-time members of the Allied Orders of the Grand Army of the Republic. On Monday, March 8, Sons of Union Veterans of the Civil War Past Department Commander Dean K. Speaks passed away at his home in Salina, Kansas. In less than twenty-four hours, his mother, Ladies of the Grand Army of the Republic Past National President Ercelle E. Speaks joined him in the arms of their Savior.

Both had devoted much of their lives to the Allied Orders. Brother Dean was directly responsible for the re-establishment of the Department of Kansas, SUVCW, in 1996. He served as National Membership at Large Coordinator in the 1990's, and was awarded the "Cornelius F. Whitehouse Award" as the "National Member of the Year" in 1996. Dean was one of the first brothers of the Department of Kansas to be awarded "Emeritus" status.

Sister Ercelle served in many posts at both the Department and National level with the LGAR, culminating with her service as National President in 1994-1995. The Kansas LGAR had previously honored her with the naming of its newest circle as the Ercelle Speaks Circle in Johnson County, Kansas.

It had been the dream of Brother Dean and his mother that Kansas would host a National Encampment. Dean was looking forward to being at this very encampment to renew old acquaintances. There would not be a Department of Kansas, nor this encampment within the Kansas borders if Brother Dean had not had a vision.

We will miss them both, but, as long as there is a Department of Kansas, they will always be with us. As we attend the 2010 National Encampment, and as we walk among our Brothers from throughout this country, know full-well that Brother Dean's and Sister Ercelle's spirits are walking here with us.

**ENCAMPMENT OPENING**

1. As required by Chapter II, Article III, Section 1 of the Regulations of the Sons of Union Veterans of the Civil War and by Article VI, Bylaws of the Department of Kansas, SUVCW, the Fourteenth Annual Encampment of the Department of Kansas, was held on April 24, 2010, at the D.A.V., Wichita, Kansas.

2. The Encampment was called to order at 10:55 AM by Department Commander James M. Converse. At that time, the Past Department Commanders were announced and filed into the room. A vacant chair remained in memory of PDC Dean K. Speaks and PDC Kenneth D. Strader.

3. The opening ceremony was conducted per the Rituals and Ceremonies of the Order.

6. The Encampment received visiting National Council of Administration Member Robert Petrovic, Department of Missouri, representing Commander in Chief Leo F. Kennedy, PDC, Department of Rhode Island. PDC Petrovic presented greetings on behalf of the Commander in Chief.

He recognized Camp 4 Commander Robert L. Wandel, who moved the 15<sup>th</sup> Annual Department Encampment be held in Lawrence. Motion was seconded and passed.

26. Commander Converse recognized PDC Russ to submit proposed resolutions of support for candidates to National offices. PDC Russ moved to submit a resolution from the Department in support of the candidacy of National Junior Vice Commander-in-Chief D. Brad Schall, Department of California and Pacific, to the position of National Commander-in-Chief. Motion was seconded and carried.

27. PDC Russ moved to submit a resolution from the Department in support of the candidacy of National Secretary Donald Palmer, Jr., Department of Missouri, to the position of National Senior Vice Commander-in-Chief. Motion was seconded and carried.

28. PDC Russ moved to support the candidacy of National Council of Administration Member Robert Petrovic, Department of Missouri, to re-election to that position.

29. Commander Converse recognized PDC Russ. PDC Russ moved, per the Bylaws of the Department, to separate the office of Department Secretary/Treasurer into the separate offices of Department Secretary and Department Treasurer. This change would become effective at the Fifteenth Annual Department Encampment on April 30, 2011. Both offices would be elected for three year terms. Motion was seconded and approved.

30. There being no more new business to come before the Encampment, Commander Converse proceeded with the nominations and election of officers.

31. At this time, Commander Converse asked the Nominating Committee to present their report. PDC Alan L. Russ presented the report. [Page C-3]

## OFFICER REPORTS

### DEPARTMENT COMMANDER REPORT

#### James M. Converse, PCC

After being elected and installed as the Department of Kansas Department Commander at the 13th Annual Department Encampment in Olathe, Kansas, on 25 April 2009, the whirlwind of activities that surround this elected position began. Accepting the challenges from PDC Dean Speaks impacted a great deal of the efforts expended by the Department the entire year.

Effort was begun to gather ideas and programs to assist the camps in addressing the newly-accepted Junior Member and Junior Associate youngsters at the camp level. Department SVC Matt Toll visited and discussed this subject with each of the active camps and reported results and recommendations back to me. The mid-to-long-term future of SUVCW lies in building new members and leaders in our ranks, with these leaders beginning their SUVCW journey as the Juniors amongst us.

I represented Franklin Camp #5 at the Shawnee Mission North High School Naval Junior ROTC Awards Night on 2 May, 2009. This national champion award-winning group clearly appreciates their relationship with the SUVCW. It is a great honor to place the SUVCW ROTC/JROTC medal on the chest of one of these wonderful high school cadets, the future leaders of our industries, cities, states and country. On 6 May, I attended Shawnee Mission West's NJROTC Awards Ceremony where Cadet Lt Commander Andrew Croft returned my salute after receiving his medal, ribbon and certificate.

I attended and was honored to speak at Franklin Camp's Memorial Day Ceremony, Saturday, 23 May, at the G.A.R. Circle at Olathe Memorial Cemetery, Olathe, Kansas.

I also marched with Franklin Camp #5 at the well-attended Shawnee Days Parade, Shawnee, Kansas, on 6 June. Many parade attendees stood and saluted our Union Flag as we passed by.

On 20 July, I delivered and set a Confederate gravestone for a distant cousin in Hutchinson, Kansas. Research ultimately showed the veteran to be a non-bloodline relative, but the experience was indeed memorable. The local newspaper printed my quote, that the war was over and the time to honor all of the brothers-in-arms had come to Private Beasley.

With our Department of Kansas delegation, I attended the 2009 SUVCW National Encampment at Louisville, Kentucky 13-15 August. It was an honor to place our Department Flag alongside each Department Flag of the SUVCW. At this time, I heard details of the intense and detailed planning and preparations that PDC Jim Knopke's committee had developed in preparation for the 2010 National Encampment in Overland Park, Kansas. As an ad hoc member of this committee, I remain in awe of their effort and congratulate each member of the committee, PDC Jim Knopke, Chairman, PDC Alan Russ, PDC Tom Schmidt and PDC Roy Lafferty. Each attendee of the history-making 2010 Annual Encampment will enjoy the results of their efforts and as a Department, we thank them for their extraordinary efforts.

I marched with Franklin Camp at the Old Settlers Parade in Olathe, Kansas on 12 September. My wife's family is amongst the Old Settler group in Olathe. It is always an honor to carry our country's flag before the public with our SUVCW brothers alongside.

I also marched behind Franklin Camp's banner at the Overland Park Fall Parade on 26 September. Although short in length, this parade has excellent public attendance. Applause for the SUVCW contingent was ongoing the entire parade route.

I led the Fall Council Meeting at the Lane Museum at Lecompton, Kansas, on 17 October as well as attended Franklin Camp's Veterans Day Ceremony at the Olathe Memorial Cemetery on 7 November.

On 10 November, I spoke at the Cedar Creek Elementary School in Olathe, Kansas. The students wanted to hear what I had done during my term in the Navy, 1968-1974, but I was able to link my service with that of our Civil War forefathers, who fought, literally, to save their country from dissolving into chaos. These youngsters are so anxious to hear of the heroes of our country. If the opportunity to speak before any group of this kind, youngsters or adults, presents itself, I would heartily recommend sharing your first-hand knowledge of your Civil War Union forefathers with them.

I was proud to march for the first time up and down the historic streets of Leavenworth Kansas on Veterans Day, 11 November. Franklin Camp and the Lenexa Kansas SCV group combined efforts on the parade to make one unit in honor of both Armies engaged in the Civil War.

I installed the new officers of Patrick Coyne Camp #1 in Wichita Kansas on 19 November, Old Abe Camp #16 in Topeka Kansas on 3 December, and Sgt. Samuel J. Churchill Camp #4 in Lawrence on 17 December.

I attended a National Encampment meeting and the Department Winter Training Session in Emporia Kansas on 9 January.

When PDC Dean Speaks and his mother, Estelle Speaks, passed away in March, I attended their funeral with other Department officers in Beloit Kansas on 12 March. The love and affection shown for these Department of Kansas and LGAR pioneers during this ceremony was abundant. They are deeply missed.

I attended the Department Spring Council Meeting in Wichita Kansas on 13 March.

As Franklin Camp Communications Officer, I edited and published eleven issues of Franklin Camp's newsletter THE OLD FLAG, a commitment I have held since founding the BUGLER and its subsequent-named THE OLD FLAG in 2006. These newsletters find their way to the hands of prospective SUVCW members and associates, other media, and friends, all to the benefit of the mission of our Order. Our Department newsletters are also archived into the history of our State at the Kansas State Historical Society in Topeka, and locally, in Franklin Camp's case, at the Johnson County Museum Archives in Shawnee Kansas. I would encourage each camp of the Department to add your individual piece of this history to the archives of Kansas. What our Union Army forefathers did was important, as is what we are doing to preserve their memory. This is ongoing history being made.

The main accomplishment of this year for the Department is forthcoming in the 2010 National Encampment taking place in Overland Park Kansas. The lion's share of Department leadership has been dedicated to planning and executing this great event. I believe their effort and follow-through to be of superior caliber. I would encourage each SUVCW member to let you Camp Commanders know that you are planning on attending at least one day of this historic event hosted by our Department. I will see you there.

It is with great regret that I am moving permanently from Kansas to Ohio after this Department Encampment adjourns. It has been my honor to serve the Department as Camp Commander, Department Council, Department JVC, Department SVC and now Department Commander. Since I will maintain my membership with Franklin Camp and the Department of Kansas, I look forward to contributing all that I can to the benefit and success of the Department.

My grandfather, Private (Wagoner) Robert B. Converse, of Company D, 177th Pennsylvania Infantry, who was Chaplain, and later, Post Surgeon of Gregory Post 326, Pawnee Rock, Kansas and then Member of Joseph Shaw Post 235, Annapolis, Illinois, would be proud indeed of the honor you have vested in me.

## HISTORIAN REPORT

As with last year's report, I hope it will please the Department Commander that I have combined my three reports.

During the last year I have not been able to pursue these projects as much as I would like, but people have continued to send me materials regarding the Last Soldier Project and the GAR Records. As the Department Historian I have responded to the inquiries that have come my way. Most of these are from descendants who live out of state, and are trying to connect with their Kansas ancestor.

The Last Soldier Project is still an area where progress needs to be stepped up a bit, as the Department in the past has discussed using this information during the Sesquicentennial, perhaps producing a book. I believe we are still 13 counties short of having a Last Soldier for each county, and there are others that need to be firmed up by further research. This is not much of a change from last year.

The search for GAR Records continues, although finding out about records in the 105 counties has come about by some of the inquiries to the Historian. This needs a more thorough search of museums and libraries across the state, and I would ask my brothers if they know of the location of GAR records, that they forward that information to me.

A continuing disappointment of the year is that I expected to have a proposal at this encampment regarding archival material that should be kept by the camps and the Department, so that copies can be turned over the archives of the Kansas Historical Society—and local historical societies—for safe keeping.

On the national level, Ed Harris, chairing the organization's Battle Flag Committee, has been in contact and at least did get the attention of Senate President Steve Morris. Nothing concrete has come out of this, as of this date, but the efforts are appreciated.

I have also been helping a distant camp outside the Department. Members of the Col. Jacob M. Campbell Camp #14 and Mary R. Campbell Auxiliary #16 in Johnstown, Pennsylvania—which by some coincidence, happens to be my hometown—have purchased the 1893 G.A.R. Hall in the city, and sharp eyes reading the Autumn, 2009 Banner may have noted they held their first meeting in the building in at least 35 years last August. I've been sending them some articles about the local G.A.R. / S.U.V. there, and also informed them where they might find some of the original furniture and camp materials.

I continue to ask for assistance in identifying and locating GAR plots in local cemeteries, and identifying the posts that purchased the plots. For instance, in Topeka we have five GAR plots in four cemeteries, purchased by four posts. My thought with this is that a listing of GAR plots may have value with genealogists, and may not be entirely incompatible with the GAR Memorials and Monuments Project.

**ATTACHMENT D – PROPOSED AMENDMENTS TO DEPARTMENT BYLAWS**

**Article II: PURPOSE**

~~Section A.~~ To perpetuate the memory of the Grand Army of the Republic and of the men who saved the Union 1861 - 1865; to assist in every practicable way in the preservation and making available for research of documents and records pertaining to the Grand Army of the Republic and its members; to cooperate in doing honor to all who have patriotically served our country in any war; to teach patriotism, and the duties of citizenship, the true history of our country, and the love and honor of our Flag; to oppose every tendency or movement that would weaken loyalty to, or make for the destruction or impairment of our constitutional Union; and to inculcate and broadly sustain the American principles of representative government, of equal rights, and of impartial justice for all.

~~Section B.~~ *[Moved to Art. IV, Section L]*

**Article III: PROHIBITED ACTIVITIES**

**Section A. NON-PROFIT.** The Department shall not be conducted for profit.

**Section B. NON-SECTARIAN AND NON-PARTISAN.** The Department, being strictly non-sectarian and non-partisan, shall not introduce, discuss or foster sectarian or partisan topics.

**Article IV. FORMATION AND DISBANDMENT CAMPS**

**Section A. FORMATION.** A Camp may be formed by authority of the Department Commander with the approval of the Commander-in-Chief.

**Section B. CAMP NAMES AND NUMBERS.** Camps shall be named in accordance with the National Regulations of the Order (Chapter 1, Article 1, Section 1). The camp number will be assigned sequentially, with the exception that no number previously used by a camp of this Department since the formation of the Department in 1996 shall be reused.

**Section C. CAMP CHARTER.** Upon the formation of a Camp, there shall be issued to it a Charter, which shall be signed by the Department Commander, attested by the Department Secretary, and approved by the Commander-in-Chief. The Charter fee for a new Camp shall be ~~as established by the National Organization~~ twenty-five dollars (\$25.00). The fee shall be paid to the Department and shall accompany the application for a Charter.

~~Section H.D.~~ **SUSPENSION OF CAMP CHARTER.** A Camp failing to pay per-capita tax or neglecting to forward reports within the time specified by law, may be suspended by the Department Commander. Suspended Camps may be reinstated by forwarding reports and paying all arrearages of per-capita taxes.

~~Section D-E.~~ **SURRENDER OF CHARTER.** No Charter shall be surrendered by any Camp, so long as ten brothers thereof, in good standing, demand its continuance; and provided further, the Department Commander and each and every brother of the Camp shall receive at least twenty (20) days notice, in person or by mail, of the intention to surrender the Charter.

**Section F. FAILURE TO PAY PER-CAPITA OR FORWARD REPORTS.** A Camp one year or more in arrears in the payment of per-capita tax and failing or neglecting to forward reports, may be disbanded and the Charter thereof revoked.

~~Section B-G.~~ **REVOCATION OF CHARTER.** The Department Commander shall have the authority to recommend to the Commander-in-Chief the revocation of the Charter of any Camp which does not conform to the Constitution and Regulations of this Order.

~~Section E-H.~~ **DISPOSITION OF CAMP PROPERTY.** In case of the surrender or forfeiture of a Charter, all of the Camp property and money shall be turned over to the Department Commander or to his duly authorized representative, and become the property of the Department. Any transfer or disposal of any of its property by a Camp in arrears for its per-capita tax shall be fraudulent and void, and any such transfer or disposal by a Camp of its property in contemplation of disbandment or surrender of its Charter shall also be fraudulent and void. All property of a Camp is held by it as a charitable trust that is to be held and used for the purpose for which this Order exists, and any such transfer or disposal within six months of disbandment or surrender of its Charter without written consent of the Department shall be conclusively presumed to be in contemplation of such disbandment or surrender. No Camp shall divide its property among its brothers.

**Section G.I. REINSTATEMENT OF CAMPS.** Camps having been ~~dropped-suspended~~ may be reinstated upon payment of a required fee of \$25.00 and may retain their original Charter.

**Section ~~I.J.~~ ASSOCIATES AND JUNIOR ASSOCIATES.** The Department permits Camps to admit Associates and Junior Associates to the Camp, provided the Camp complies with all of the provisions of the Constitution of the Sons of Union Veterans of the Civil War. Camp bylaws must permit Associates and Junior Associates in the camp in order to allow Associates and Junior Associates to join the camp.

### **Section ~~J.K.~~ DEPARTMENT MEMBERS AT LARGE (DMAL).**

(a) In accordance with Chapter II, Article X, Section 1, National Regulations, the Department shall ~~not maintain~~ allow Department Members at Large (DMAL).

(b) Brothers shall be assigned to the DMAL only after the application has first been processed as shown, below. No brother will be placed directly into the DMAL without having first been assigned to a camp for the remainder of the current membership year unless approved by the Department Commander.

(c) When applications are received from the National Organization for MAL, the Department Junior Vice Commander shall contact the brother and give him the opportunity to select one of the Camps in the Department to join.

(d) If the new MAL does not elect to choose a Camp, he shall be assigned to the Camp closest to his place of residence.

(e) The Department Council shall develop and maintain a map of the Department to serve as a guideline for Camp assignment.

(f) A separate camp shall not be established for DMAL. The Department Secretary shall be responsible for the administrative requirements concerning brothers assigned to the DMAL.

**Section L. ELECTION AND INSTALLATION OF CAMP OFFICERS.** Camps shall hold annual elections of officers as follows:

(a) Camps which hold meetings in December shall hold the election of camp officers at their first November meeting. The officers shall be installed at the first December meeting.

(b) Camps which do not meet in December shall hold the election of camp officers at their first October meeting. The officers shall be installed at the first November meeting.

(c) Camps which meet less than monthly must hold a meeting in November or December for the election and installation of officers at the same meeting. The camp must assure this does not delay the forwarding of the report of election and installation of officers.

(d) Camps shall furnish the exact dates of their scheduled election and installation to the Department Secretary no later than September 30, each year.

(e) The Department Commander shall install all camp officers, if possible. In those instances where the Department Commander is unable to install the new officers, he shall appoint a brother to install the camp officers.

(f) The Department Commander or other installing officer shall forward the report of election and installation of camp officers to the Department Secretary within seven (7) days of the installation.

**Section M. USE OF RITUAL AND CEREMONIES AT CAMP MEETINGS.** The Ritual and Ceremonies of the Order are an integral and historic part of the Sons of Union Veterans of the Civil War. As such, all Camps within the Department of Kansas shall conduct meetings as provided in the Rituals and Ceremonies of the Order, except when circumstance are prohibitive.

## Article V: MEMBERSHIP

**Section A. GOVERNING OF DEPARTMENT.** The Department shall be governed by its Department Encampment, subordinate to the National Organization.

**Section B. MEMBERSHIP OF DEPARTMENT ENCAMPMENT.** The membership of the Department Encampment shall be constituted as follows:

(a) All Past Commanders-in-Chief, Past Department Commanders and Past Camp Commanders, in good standing, who have served a full term or, having been elected to fill a vacancy, have served to the end of that term, and its sitting Camp Commanders.

(b) One Delegate from each Camp, whatever its membership, and one additional Delegate for every ten brothers, or major fraction thereof, based upon the annual report ending March 31 immediately prior to the Department Encampment. As such, the camp annual reports must be submitted to the Department Secretary so as to arrive no later than three (3) days prior to the scheduled date of the Department Encampment.

(c) Its own Elective Officers.

(d) Any brother serving as Camp Secretary or Camp Treasurer continuously in office for a period of ten years may have conferred upon him the rank of Past Camp Commander, with its voting privileges at the Department Encampment.

~~Section C.~~(e) Vacancies in delegate representation to and at the time of the Department Encampment may be filled by a vote of the delegates from the Camp in attendance at the Encampment; the Camp Commander having the prior right to appoint brothers to fill vacancies.

~~Section D.~~(f) A Camp which fails to pay its per-capita tax or other indebtedness or fails to make reports, shall not be entitled to representation at the Department Encampment.

**Section EC. RESTORATION OF RANK OF PAST CAMP COMMANDER.** To obtain restoration of rank of Past Camp Commander the brother shall make request in writing to the Camp of which he is a brother. If acted upon favorably by the Camp in regular session, said request shall be forwarded to the Department Commander, setting forth the causes of loss of rank, and reasons for the request of restoration. The Department Commander shall present same to the Department Encampment where, if acted upon favorably, such rank shall be restored.

### Article VI: MEETINGS

**Section A. DEPARTMENT ANNUAL ENCAMPMENT.** The Department shall meet in Annual Encampment. Said Annual Encampment shall be held on the **Fourth weekend in April** each year. If, for any reason, the "Host Camp" (as defined in Article VI, Section F) determines that it needs the date(s) of the Annual Encampment to be changed on a "one-time" basis, then the Department Commander shall call for a Special meeting of the Department Encampment (as defined in Article VI, Section B), at a time and place of the Department Commander's choosing, by and with the consent of the Department Council, for the express purpose of changing the date(s) of the Annual Department Encampment.

**Section B. SPECIAL DEPARTMENT ENCAMPMENTS.** Special meetings of the Department Encampment may be called by the Department Commander, by and with the consent of the Department Council; but no business shall be transacted at any special meeting other than that for which it was specifically called, which call shall state the purpose and object of said meeting.

**Section C. QUORUM.** A majority of the membership reported present and entitled to vote shall constitute a quorum.

**Section D. DISPLAY OF FLAGS AND CHARTER.** All meetings of the Department shall have a United States Flag, the Department Flag, and the Department Charter displayed.

**Section E. CONDUCTING MEETINGS.** All meetings of the Department shall be conducted via the guidelines of the Constitution and the Rules and Regulations of the National Organization of the Sons of Union Veterans of the Civil War, the Ritual of the Order, and the current edition of Robert's Rules of Order, in that order.

#### **Section F. HOST CAMP.**

(a) A camp which wishes to host the Annual Department Encampment, shall submit a proposal to the Spring Council Meeting the year preceding the subject encampment.

(b) Proposals to host the Annual Department Encampment shall include the proposed location, the ability to meet the facility needs for the encampment, to include meeting facility for the LGAR, primary point of contact for additional information, and estimated cost of Noon meal, if provided.

## PROCEEDINGS OF THE FOURTEENTH ANNUAL ENCAMPMENT

(c) Camps who intend to submit proposals shall notify the Department Secretary at least one week prior to the Spring Council Meeting in order that adequate time may be allocated during the meeting.

(d) In the event that no proposals are submitted, the Department Council will solicit proposals from one or more camps.

(e) The Department Council shall review submitted proposals and submit them to the Annual Department Encampment for final approval.

**Section G. INABILITY OF HOST CAMP TO HOST ENCAMPMENT.** In the event that the designated "Host Camp" for that year's Annual Encampment shall be unable, for any reason, to host that year's Encampment they shall notify the Department Commander, in writing, as soon as this information becomes available. The Department Commander may call a special meeting of the Department Encampment in accordance with Article VI, Section B, to resolve the situation.

**Section H. FALL COUNCIL MEETING.** The officers of the Department shall conduct the "Fall Council Meeting" each year on the **third Saturday of October**. The location and time for the meeting shall be determined by the Department Commander.

(1) **Purpose.** The Fall Council Meeting shall be for the purpose conducting the routine business of the Department, to include approving expenditures, policies, and procedures. The Department Council will not take actions which are reserved for the Department Encampment. Likewise, any action of the Department Council may be overruled by action of the next Department Encampment.

(2) **Voting Members.** The elected offices of the Department and the immediate Past Department Commander are the voting members of the Department Council.

(3) **Non-voting Members.**

(a) All appointed Department Officers are members of the Council, without vote, and should be in attendance.

(b) All brothers of the Department holding the honor of Past Department Commander are members without vote, and, as such, encouraged to attend the meeting.

(4) **Other Attendees.**

(a) Camp Commanders, or their designated representative, should attend. They should be prepared to report on the activities of their camp. This provides an opportunity for communication between the Department Officers and the camps. Camp Commanders or representatives are attendees without membership on the Council and without vote.

(b) All brothers of the Department are permitted and encouraged to attend the meeting without voice or vote. Any attendee may request of the Department Commander to present an item to the meeting or to provide discussion or comments on an item being discussed at the meeting. It shall be the decision of the Department Commander as to whether this shall be permitted.

**Section I. WINTER TRAINING SESSION.** The Winter Training Session for the Department shall be conducted on the **second Saturday of January**. The location and time for the meeting shall be determined by the Department Commander. The purpose of the Winter Training Session is to provide updated information and training to the elected officers of the Camps. This meeting is scheduled to have the greatest impact on the newly elected camp officers.

(1) Trainers/Presenters will be the elected Department officers or designee.

(2) Attendees should be the Camp Commanders, Camp Senior Vice Commanders, Camp Junior Vice Commanders, and Camp Secretaries/Treasurers.

**Section J. SPRING COUNCIL MEETING.** The officers of the Department shall conduct the "Spring Council Meeting" each year on the **second Saturday of March**. The location and time for the meeting shall be determined by the Department Commander, with preference given to locating it at the camp which will be the host camp for the upcoming Department Encampment. The attendees, purpose, and limitations are as described for the Fall Council Meeting, above.

## Article VII: OFFICERS

### Section A. DEPARTMENT OFFICERS.

(1) The Officers of the Department shall be the Department Commander, Senior Vice Department Commander, Junior Vice Department Commander, three brothers of the Department Council, Department Patriotic Instructor, Department Chaplain, Department Secretary, Department Treasurer, Department Historian, Department Counselor, Department Graves Registration Officer, and Department Civil War Memorials Officer, Guide, Color Bearer, and Guard. The offices of Department Secretary and Department Treasurer may be combined into the office of Department Secretary/Treasurer. The incoming Department Commander may delay appointing brothers to the offices of Guide, Color Bearer, and Guard until the next Department Encampment, at which time he will appoint them *pro tempore*.

(2) The combined office of Department Secretary/Treasurer may be replaced with the separate offices of Department Secretary and Department Treasurer.

(a) Such change shall require a majority vote of the Department Annual Encampment, with such vote occurring prior to the official call for nominations for the office.

(b) Such change shall only occur at the end of the normal term of office for the then current Department Secretary/Treasurer.

(c) Such change shall not require further amendment to the Bylaws of the Department of Kansas to implement.

(3) The separate offices of Department Secretary and Department Treasurer may be replaced with the combined office of Department Secretary/Treasurer.

(a) Such change shall require a majority vote of the Department Annual Encampment, with such vote occurring prior to the official call for nominations for the offices.

(b) Such change shall only occur at the end of the normal term of office for the then current Department Secretary and Department Treasurer.

(c) Such change shall not require further amendment to the Bylaws of the Department of Kansas to implement.

### Section B. ELECTION OF OFFICERS, DELEGATES, AND ALTERNATES.

(1) The Department Commander, Senior Vice Department Commander, Junior Vice Department Commander, Department Council, Department Secretary/Treasurer or Department Secretary and Department Treasurer, Delegates and Alternates to the National Encampment shall be elected at the annual encampment by a roll-call of Camps in numerical order.

(a) A majority of all the votes cast shall be necessary to elect Department Commander, Senior Vice Department Commander, Junior Vice Department Commander, Department Secretary, and Department Treasurer (or Department Secretary/Treasurer).

(b) Delegates and Alternates will be elected by a plurality of the votes.

(c) When electing Department Council Members for terms of office with differing length of terms, or when filling an unexpired term, The positions will be elected separately, as follows. Positions being elected for two-years terms will be elected first. All Council Members for two-year terms may be elected in the same vote. Next, any positions for one-year terms, normally to fill a vacancy in an unexpired term, will be elected. All Council Members for one-year terms may be elected in the same vote. Council Members will be elected by a plurality of the votes cast.

(d) If there is but one nominee for an office the Department may elect by viva voce vote.

(2) Provided, that no brother shall be eligible for election to the office of Department Commander unless he has served as a Camp Commander. No brother shall be eligible for election to the office of Department Commander who is not present and entitled to vote at the Department Encampment.

## PROCEEDINGS OF THE FOURTEENTH ANNUAL ENCAMPMENT

(3) No brother shall be eligible for election to the Department offices of Senior Vice Department Commander or Junior Vice Department Commander unless he has served, or is currently serving, as a Camp Commander. No brother shall be eligible to be nominated for election to the office of Senior Vice Department Commander or Junior Vice Department Commander who is not present and entitled to vote at the Department Encampment. In the case of a nominee for Senior Vice Department Commander or Junior Vice Department Commander, the nomination of a brother to these offices, and the election thereto, may occur in his absence provided that:

(a) A motion to nominate in his absence is made and approved by two-thirds(2/3)of the voting membership present at the Department Encampment; and

(b) The brother to be nominated has submitted, in writing, a statement, that, if he is elected to the position for which he is to be nominated, he will provide satisfactory service during his term of office; and

(c) The brother to be nominated has stated in writing that he knows of no reason to prevent him from performing his duties during the coming year, and that he will attend the following Department Encampment.

**Section C. APPOINTED OFFICERS.** On assuming office, the Department Commander shall appoint all other Department Officers not elected; and may appoint an Assistant Secretary and/or Assistant Secretary/Treasurer. The duties of appointed positions, for which no appointee is designated, shall be retained by the Department Commander.

**Section D. TERMS OF OFFICE.** The term of all elective and appointed officers shall be as follows:

(1) The Department Commander, Senior Vice Department Commander, and Junior Vice Department Commander shall be elected for a term of one year. No Department Commander may be reelected to that position for more than three (3) consecutive terms, or if such election will result in him serving as Department Commander for more than 45 consecutive months.

(2) The term of all elective ~~and appointed~~ officers, except the office of Secretary/Treasurer or Department Secretary and Department Treasurer, ~~and Council Members~~, shall be for one year.

(3) The term of office for Secretary/Treasurer or Department Secretary and Department Treasurer shall be for three (3) years, commencing with the 2008 term.

~~(3)~~(4) Department Council Members will be elected for a two-year term of office, with one position being elected in odd-numbered years and two positions being elected in even-numbered years. Any Council Member vacancy which should occur between Department Encampments shall be filled in accordance with Section F, below. In the case where the term of office for that position would normally extend beyond the next Department Encampment, the remainder of the term shall be filled by a brother elected at that Department Encampment. This provision shall be implemented at the 14th Department Encampment in 2010, with two positions being elected for two-year terms of office and one position being elected for a one-year term of office at that time.

~~(4)~~(5) Appointed officers of the Department shall be appointed by the Department Commander to serve for a period of up to one year, unless sooner relieved. All appointments shall expire automatically at the end of the next Department Encampment, unless otherwise defined by these Bylaws.

**Section E. INSTALLATION OF DEPARTMENT OFFICERS.** The installation of Department Officers shall be performed at the Encampment by some person chosen by the Department Commander Elect.

**Section F. VACANCY IN DEPARTMENT ELECTIVE OFFICE.** Any vacancy which may occur in an elective office of the Department shall be filled by a majority vote of the Department Council for the period until the next regular meeting of the Department Encampment.

**Section G. REMOVAL OF OFFICER.** Any officer delinquent in or failing to perform the duties of his office may be removed from office by the Department Commander or by the Commander-in-Chief.

### Article VIII. DUTIES OF OFFICERS

**Section A. DEPARTMENT COMMANDER.** The Department Commander shall be the executive officer of the Department, charged with the duty of administering the affairs of the Department. He shall preside at all meetings of the Department Encampment; appoint all the standing and other committees (of which he shall be a member ex-officio) unless otherwise prescribed by the Encampment. He shall supply to each Camp Secretary and

Camp Treasurer an adequate supply of report blanks. He shall at frequent intervals contact Camps, their Officers, Department Officers, and issue Department Orders and official communications. He should perform all other such duties as prescribed for his position in "*Job Descriptions for Camp and Department Officers*", prepared by the National Organization, Committee on Program and Policy.

**Section B. SENIOR VICE DEPARTMENT COMMANDER.** The Senior Vice Department Commander shall temporarily and respectively perform the duties of the Department Commander in the case of the senior officers' incapacity or inability to perform his duties. The Senior Vice Department Commander should also perform such other duties as are described for his own position in "*Job Descriptions for Camp and Department Officers*", prepared by the National Organization, Committee on Program and Policy.

**Section C. JUNIOR VICE DEPARTMENT COMMANDER.** The Junior Vice Department Commander shall temporarily and respectively perform the duties of the Department Commander in the case of the senior officers' incapacity or inability to perform his duties and the inability of the Senior Vice Department Commander to perform the duties. The Junior Vice Department Commander should also perform such other duties as are described for his own position in "*Job Descriptions for Camp and Department Officers*", prepared by the National Organization, Committee on Program and Policy.

**Section C.D. SECRETARY OR SECRETARY/ TREASURER.** The Department Secretary or Secretary/Treasurer, in his capacity as Secretary, shall keep a true and accurate record of the proceedings of the Department Encampment. He shall keep and be the custodian of the files and membership records of the Department, and shall keep such other records in connection with his office as may be required by the Department Commander or the Department Encampment. He shall, by the due date established in National Regulations, make a consolidated report of the Camp Secretary's reports to the Department Commander, and forward a copy of same to the National Executive Director, together with the amount due for per-capita and application fees. He shall, by the fifteenth day of each month, forward to the National Executive Director all Camp Status Reports received from Camps for the previous month. He shall forward a report of the election of officers, delegates and alternates to the National Secretary and National Executive Director within thirty (30) days after such election, and perform all other duties pertaining to his office as described in "*Job Descriptions for Camp and Department Officers*", prepared by the National Organization, Committee on Program and Policy.

**Section D.E. TREASURER OR SECRETARY/ TREASURER.** The Department Treasurer or Secretary/Treasurer, in his capacity as Treasurer, shall hold the funds of the Department and pay out the same upon requisition in due form from the Department Secretary, approved by the Department Commander. He shall have charge of all property of the Department not otherwise provided for, shall keep a true and accurate account of all receipts and expenditures, and perform such other duties as described in "*Job Descriptions for Camp and Department Officers*", prepared by the National Organization, Committee on Program and Policy.

**Section E.F. COUNCIL.** The Department Council, immediately after its installation, shall meet and elect a Chairman and Secretary. It shall devise and recommend such measures as will enable the Department to meet all of its necessary expenditures, and shall audit the receipts, expenditures and books of account of the Department and make a report, thereof, to the Department Encampment. Any permanent vacancy in a Department elective office shall be filled for the remainder of the term by a Brother elected via majority vote of the Department Council. The Department Council shall perform such other duties as described in "*Job Descriptions for Camp and Department Officers*", prepared by the National Organization, Committee on Program and Policy. The Department Council shall also meet during the Fall for the purpose of auditing the records of the Department and discussing the state of the Department. This meeting shall normally be in October at a time and place determined by the Department Commander.

**Section F.G. PATRIOTIC INSTRUCTOR.** The Department Patriotic Instructor shall prepare letters of instruction for the observance of Memorial Day and other patriotic occasions and events and perform such other duties as pertain to his office as described in "*Job Descriptions for Camp and Department Officers*", prepared by the National Organization, Committee on Program and Policy.

**Section G.H. CHAPLAIN.** The Department Chaplain shall have charge of the devotional exercises of the Department Encampment, shall prepare letters of instruction for the observance of Memorial Day, and perform such other duties as pertain to his office as described in "*Job Descriptions for Camp and Department Officers*", prepared by the National Organization, Committee on Program and Policy.

**Section H.I. COUNSELOR.** The Department Counselor shall act as a legal advisor to the Department Commander and the Department on matters concerning the Department or Camps and perform such other duties as described in “*Job Descriptions for Camp and Department Officers*”, prepared by the National Organization, Committee on Program and Policy.

**Section H.J. ASSISTANT SECRETARY.** The Assistant Department Secretary shall perform such duties as prescribed by the Department Secretary.

**Section J.K. CIVIL WAR MEMORIALS OFFICER.** The Department Civil War Memorials Officer shall serve as the Department point of contact for all matters pertaining to the Memorials and Monuments program and perform such duties as described in “*Job Descriptions for Camp and Department Officers*”, prepared by the National Organization, Committee on Programs and Policy.

### Article IX: FINANCES

**Section A. DUES AND REVENUE.** The Department shall regulate its own dues and revenues. The amount of said dues shall be set by the Department Encampment.

**Section B. CHARTER FEES.** The Department shall pay to the National Organization, the appropriate fee, as established by the National Organization, for the Department Charter and for each Camp Charter, which amount shall accompany the application and shall be forfeited if the Camp is not instituted within six (6) months from the date of application. The Department shall pay to the National Organization, the appropriate fee, as established by the National Organization, for the reinstatement of Camps which have been dropped.

### Article X: COMMITTEES

**Section A. AUTHORITY TO APPOINT.** The Department Commander shall appoint the members of all committees of the Department.

**Section B. MINE CREEK BATTLEFIELD COMMITTEE.** The Mine Creek Battlefield Committee, established by the Tenth Annual Department Encampment, shall be responsible for working with both the Mine Creek Battlefield Foundation and the Kansas State Historical Society for the purpose of bettering the Mine Creek Battlefield. Such committee shall keep the Department Commander informed of its activities. The chairman of the committee shall report annually to the Department Encampment. The committee shall consist of five brothers appointed by the Department Commander, ~~one of whom shall be a brother with Mine Creek Camp 6.~~

**Section C.** *(Deleted)*

**Section D. APPOINTMENT OF SPECIAL COMMITTEES.** The Department Commander, at his discretion, may appoint Special Committees whose duties and life span shall be directed by the Department Commander in the orders establishing said committees.

**Section E. COMMITTEE MEMBERSHIP.** Each committee shall consist of no more than five members and shall prepare a report to be presented to the Department Encampment on their activities for the year. A copy of the committee report shall be forwarded to the Department Commander and the Department Secretary who shall include such reports in the minutes of the Department Encampment.

### Article XI: BOOKKEEPING

**Section A. FISCAL YEAR OF DEPARTMENT.** The fiscal year of the Department shall begin on 01 January and end on 31 December of each year.

**Section B. FINANCIAL STATEMENTS AND AUDITS.** Annual financial statements of the Department, prepared with generally accepted accounting principles, shall be prepared after the end of each fiscal year and shall be presented to the Department Encampment. All financial statements shall be subjected to an annual audit; the results of which shall be reported to the Department Council and the Department Commander.

**Section C. DEPARTMENT FUNDS.** All Department funds shall be deposited in a reliable depository as the Department Council may direct. The Department may have a checking and a savings account. The **Department Treasurer** or Department Secretary/Treasurer may disburse funds from the checking account. The **Department Treasurer** or Department Secretary/Treasurer may not disburse checking account funds in excess of \$50.00 for any

one single item without written approval on a Department Voucher. Approval shall be secured from the Department Commander or the Department Council. The **Department Treasurer** or Department Secretary/Treasurer may not withdraw or transfer funds from the savings account without written approval on a Department Voucher from the Chairman of the Department Council.

**Section D. REIMBURSEMENT OF EXPENSES.** Department Officers may be entitled to reimbursement of certain expenses necessary for the conduct of their respective office provided, however, that a written request is presented to and approved by the Department Commander. In the case of a request from the Department Commander, approval for reimbursement of expenses must be secured from the Department Council. Typical expenses would include, but not be limited to, long distance telephone costs, postage and mileage.

### Article XII. DEPARTMENT AWARDS

**Section A. AUTHORITY.** Authorization for Department Awards are provided. The name and type of awards shall be determined by the Department Commander. A copy of the citation presenting any award to a brother of the Department of Kansas shall be placed in the recipient's file with his Camp Secretary along with being recorded in the minutes of the Department Encampment for the award year by the Department Secretary.

**Section B. EMERITUS STATUS.** In accordance with National Regulations of the Order, a brother who has served as an elected Department officer may be granted Emeritus status, subject to provisions listed below. Such status shall be in recognition for contributions and length of service as an elected officer of the Department of Kansas.

a. Granting of Emeritus status must be approved by vote of the membership at a regular Department Encampment. Request for granting of Emeritus status may be made by camp resolution, or a letter of recommendation from another brother. Request must be received by the Department Secretary prior to the beginning of the Department Encampment.

b. Emeritus status shall not be granted to a currently serving elected officer of the Department nor to a brother who has been elected as an officer and is about to take office. It may be awarded to current officers who is leaving office at the end of the current encampment.

c. Emeritus status is granted permanently; however, such status may later be withdrawn for cause by action of a subsequent Department Encampment.

d. A brother who has received Emeritus status and is elected to a Department office at a subsequent Department Encampment or is appointed to fill an unexpired term of an elected Department office shall retain Emeritus status.

e. A brother so granted Emeritus status is entitled to wear the badge of a Department elected officer, as described in the National Regulations of the Order.

**Section C. PERMANENT AWARDS.** The following awards, having been well established within the Department of Kansas by precedent, are established as permanent awards of the Department. These awards, and their criteria, are as follows:

(1) **CORPORAL LEONIDAS B. DAVIS AWARD FOR RECRUITER OF THE YEAR.** This award may be presented by the Department Commander to the brother who has recruited the most new brothers (Members, Associates, Junior Members, and Junior Associates) since the previous Department Encampment. The determination of which brother is to receive credit for a new brother is based upon the name entered on the application for membership as "Recommended by SUVCW Brother." Applications received from the National Junior Vice Commander-in-Chief are not considered when determining the number of "recruits." The Department Commander may determine not to present the award any year he feels no one has recruited enough brothers to set him apart in this regard.

(2) **CAPTAIN PATRICK H. CONEY AWARD FOR BROTHER OF THE YEAR.** This award is presented by the Department Commander to the brother whom the Department Commander has determined to have performed significant service to a camp or the Department within the past year. The Department Commander shall seek recommendations from the various Camp Commanders for this award.

(3) **LEANDER STILLWELL OUTSTANDING ACHIEVEMENT AWARD.** This award may be presented by the Department Commander to the brother who has performed significant service to the Department of

Kansas or the organization as a whole over an extended period of time. The Department Commander may seek recommendations from Camp Commanders, Department Officers, Past Department Commanders, and others. This award is neither required nor expected to be awarded each year.

(4) **WILLIAM W. NIXON AWARD FOR CAMP OF THE YEAR.** This award is presented by the Department Commander to the camp within the Department which demonstrated the greatest degree of support to the goals and ideals of the Sons of Union Veterans of the Civil War in such areas as community involvement, memorial ceremonies, public education, conduct of camp meetings, and such. The Department Commander shall seek recommendations from the various Camp Commanders for this award.

### Article XIII. INCLUSION OF NATIONAL RULES AND REGULATIONS

Included herein by reference and made a part of these Bylaws are the following rules and regulations, and any subsequent amendments or modifications thereto:

1. Constitution and Regulations of the Sons of Union Veterans of the Civil War,
2. Rules and Regulations, Sons of Veterans Reserve.
3. Job Descriptions for Camp and Department Officers.
4. Policies and Procedures of the Sons of Union Veterans of the Civil War.

### Article XIV. SUSPENSION OF BYLAWS

There shall be no suspension of these Bylaws during any meeting of the Department.

### Article XV. BYLAWS AMENDMENTS

**Section A. AMENDMENT PROCESS.** These Bylaws may be amended at any meeting of the Department Encampment by a 2/3 vote of the voting brothers present at said meeting, subject to the following:

(a) The Department Commander shall appoint a Bylaws Committee, or designate that the full council shall function as the committee, for the purpose of reviewing and/or proposing changes to the Department Bylaws. Copies of proposed changes to the bylaws, as recommended by the Bylaws Committee, shall be forwarded to each camp secretary no later than 30 days prior to the Department Encampment.

(b) Proposed amendments may be submitted to the Bylaws Committee, through the Department Secretary, no later than 45 days prior to the Department Encampment. All proposed amendments must be submitted by the Camp Commander, attested by the Camp Secretary, after having been voted on at a previous meeting of the proposing Camp.

(c) A proposed amendment not previously submitted, as above, may be introduced at the Department Encampment by any Voting brother of the Encampment. The proposed amendment shall be reviewed by an Encampment Bylaws Committee during a break in the business meeting. Such committee shall present its recommendation concerning the amendment to the encampment where the encampment will then act upon the proposal.

(d) Before becoming effective, all Bylaws and Bylaw amendments shall be approved by the Commander-in-Chief in writing.

**Section B. REPEAL OF PREVIOUS BYLAWS.** All Bylaws heretofore adopted by the Department are hereby repealed.

### Article XVI. DEPARTMENT OF KANSAS GUARD

**Section A. ESTABLISHMENT.** Under the authority of Chapter IV, Article I, Section I, National Regulations of the Order, the Department of Kansas has established the DEPARTMENT OF KANSAS GUARD, herewith referred to as the "Department Guard," as an independent military organization within the Department of Kansas.

**Section B. PURPOSE.** It shall be the purpose of the Department Guard to provide a uniformed presence for parades, services, and ceremonies under the auspices of the Department of Kansas.

**Section C. COMMANDING OFFICER.** The commanding officer of the Department Guard shall hold a commissioned officer rank up to and including the rank of captain. Such rank shall be awarded by the Department Council upon the recommendation of the Department Commander. A commanding officer may be appointed for a period of up to three (3) years. All such appointments shall be announced by Department Order.

**Section D. FIRST SERGEANT.** The commanding officer of the Department Guard shall have the authority to recommend the appointment of a senior non-commissioned officer with the rank of first sergeant. Such rank shall be awarded by the Department Council upon the recommendation of the Department Commander. A first sergeant may be appointed for a period of up to three (3) years. All such appointments shall be announced by Department Order.

**Section E. COLOR BEARERS AND COLOR GUARDS.** The commanding officer of the Department Guard shall have the authority to appoint necessary color bearers and color guards with ranks of corporal and sergeant. The commanding officer shall notify the Department Commander of any such appointments and shall request that the appropriate Department Order be published.

**Section F. ROSTER.** The commanding officer shall furnish the Department Secretary a current roster of the Department Guard whenever any changes to the roster occur.

**Section F. UNIFORMS.** All members of the Department Guard shall wear appropriate Civil War era uniforms, accompanied by appropriate equipment, as directed by the commanding officer.

**Section F. SUBORDINATE TO SVR.** As required by the National Regulations of the Order, the Department Guard, when participating “where Camp Guard units, Department Guard units and SVR units are participating, the highest ranking SVR commissioned or non-commissioned officer shall have command of all military bodies of the SUVCW, regardless of the rank of an officer in a Camp Guard or Department Guard.” (Chapter IV, Article I, Section I)

**Section F. CAMP GUARDS SUBORDINATE TO DEPARTMENT GUARD.** Any Camp Guard units, whether officially established or not, shall fall under the command and authority of the commanding officer, Department Guard, at any function or activity where the Department Guard is officially present.
