**PROCEEDINGS OF THE SEVENTEENTH ANNUAL ENCAMPMENT
DEPARTMENT OF KANSAS
SONS OF UNION VETERANS OF THE CIVIL WAR
January 12, 2013
Emporia, Kansas**

1. As required by Chapter II, Article III, Section 1 of the Regulations of the Sons of Union Veterans of the Civil War and by Article VI, Bylaws of the Department of Kansas, SUVCW, the Seventeenth Annual Encampment of the Department of Kansas, was held on January 12, 2013, at the Emporia Senior Center, Emporia, Kansas.
2. The Encampment was called to order at 10:05 AM by Senior Vice Department Commander Rocky L. Bartlow. At that time, the Past Department Commanders in attendance were announced and filed into the room. A vacant chair remained in memory of PDC Dean K. Speaks and PDC Kenneth D. Strader.
3. After the Past Department Commanders were seated, the gavel was passed to Department Commander Roy A. Lafferty, PDC, who received honored guests, National Commander-in-Chief Perley E. Mellor, PDC, Sons of Union Veterans of the Civil War, and his wife, National Vice President Diane Mellor, Auxiliary to the Sons of Union Veterans of the Civil War. Both gave brief comments.
4. At 10:10 AM, Commander Lafferty officially opened the encampment. The opening was conducted per the Rituals and Ceremonies of the Order.
5. The Department Secretary called the roll of officers, and reported all officers present:

 - Council Member Thomas E. Schmidt, PDC, Camp 1, present.
 - Council Member and Chaplain Mark A. Britton, Camp 1, present.
 - Council Member, Patriotic Instructor, Graves Registration Officer, and Eagle Scout Coordinator, William E. Fischer, Jr., PCC, Camp 5, present.
 - Civil War Memorials Officer Douglas E. McGovern, PCC, Camp 1, present.
 - Historian Blair D. Tarr, Camp 16, present.
6. The opening of the Encampment concluded with Chaplain's prayer.
7. Commander Lafferty informed the Encampment of "housekeeping rules" to be used during the meeting.
8. At this time, the PDC Alan Russ presented the Credentials Committee report of those present at the Encampment, as follows:

9. Commander Lafferty appointed PDC Alan L. Russ as Chairman of the Encampment Bylaws Committee, with PDC Thomas E. Schmidt and PDC James R. Knopke as committee member.

10. Commander Lafferty appointed PCC Rocky L. Bartlow as Chairman of the encampment Resolutions Officers' Report Committee, with PCC Kent M. Melcher and PCC Mark A. Britton as committee members.

13. Secretary Russ reported the following correspondence had been received by the Department Secretary since the last Encampment..

- a. Letter from National Secretary Eugene Mortoff about the requirement for Departments to vote on ratification of a proposed Constitutional amendment.
 - i. Commander Lafferty referred action to "New Business."
- b. Statement of intent by Eugene Mortoff, PDC, Department of Chesapeake, to run for National Junior Vice Commander-in-Chief.
 - i. Commander Lafferty ruled no further action was required.

14. Commander Lafferty noted there was no unfinished business from the Sixteenth Encampment. He did recognize Graves Registration Officer Fischer, who addressed the Encampment about the need to follow the policies and procedures for requesting grave markers from the Veterans Administration.

15. Commander Lafferty then called for Committee and other reports.

16. The following committee reports were presented and accepted by the Encampment as written:

- a. Report on 2012 National Encampment – Alan L. Russ, PDC [Page C-1]
- b. Bylaws Committee Report – Alan L. Russ, PDC [Page C-2]
 - i. Commander Lafferty declared the proposed changes to the Department Bylaws be addressed under "New Business."
- c. Commander Lafferty declared that the Nominating Committee report was to be held until the start of the nomination process.

- d. PDC Thomas E. Schmidt, Department Council member, presented a report as to the satisfactory state of the funds of the Department. [Page C-2]

17. At 11:55 AM, Commander Lafferty directed the Chaplain to close the Bible. Commander Lafferty then declared a recess for lunch. The Encampment was reconvened at 1 PM, moving to "New Business."

18. At the end of the lunch recess, Commander Lafferty, SVDC Bartlow, and JVDC Melcher paid an official visit to the Department of Kansas Ladies of the Grand Army of the Republic.

19. At 1:15 PM, the Encampment was reconvened for the purpose of addressing "New Business" to come before the Encampment.

20. Secretary Russ was called upon to present the proposed Constitutional Amendment to the Encampment. It was moved and seconded to approve the amendment. After discussion, Commander Lafferty called for a show of hands for those in favor of the motion. Those voting in favor were counted. The same was done for those opposed to the motion. The final vote was 31 in favor, 0 opposed, and 1 not voting. Commander Lafferty declared the motion carried and instructed the secretary to notify the National Secretary.

21. Secretary Russ was then called upon to present the proposed amendments to the Department of Kansas Bylaws. Each amendment was presented, moved to be accepted, and voted upon. All six amendments were passed. Amendment 2012-02, which changes the preamble to the Bylaws based upon the pending National Constitution amendment, will not be approved by CinC Mellor until after the Constitutional Amendment has been ratified. The secretary will submit the amendments to the CinC, with 2012-02 being submitted for separate action.

22. Commander Lafferty requested to know which past department commanders planned to attend the 2013 National Encampment. Commander Lafferty stated he and Secretary Russ would be attending in their capacities as PDC. SVDC Bartlow stated he would be attending, most likely in the capacity as Department Commander. PDC Schmidt and PDC Sundell stated they were also planning to attend in that capacity.

23. Commander Lafferty stated the Department of Kansas was entitled to six delegates to the National Encampment. Commander Lafferty asked for nominations from the floor for the election of delegates to the 132nd National Encampment. PDC Russ nominated the following to be delegates:

- a. PCC William E. Fischer, Jr., Camp 5
- b. PCC Kent M. Melcher, Camp 16
- c. Jonathan F. Birket, Camp 1
- d. Paul Jefferson, Camp 4
- e. David P. Tollefson, Camp 5
- f. Conrad M. Fisher, Camp 16

24. The motion for election of delegates was seconded and approved. These brothers will be so indicated on the Form 49 submitted to National Headquarters.

25. Commander Lafferty recognized PDC Russ, who moved, "All Members and Associates of the Department of Kansas who are in good standing as of this date (January 12, 2013) and are not otherwise entitled to membership at the 132nd National Encampment nor elected as a "Delegate" to the 132nd National Encampment shall be elected as "ALTERNATE DELEGATES" to the 132nd National Encampment of the Sons of Union Veterans of the Civil War, August 9-10, 2013, in Brookfield, Wisconsin. A listing of those so elected as Alternate Delegates shall be included in the official proceedings of this encampment and shall be attached to the Department of Kansas Certificate of Election and Installation of Department Officers (SUVCW Form 49) and forwarded to the National Headquarters." Motion was seconded and passed. [Page F-5]

26. Commander Lafferty announced that, per the Department Bylaws, the 18th Annual Encampment of the Department of Kansas would be on January 11, 2014. Commander Lafferty entertained a motion that the encampment be hosted by the Department at large. Motion by Paul Jefferson was seconded and passed.

27. Commander Lafferty called upon Treasurer Russ to present discussion on the proposed budget for 2013. Copies had been distributed to the members of the Encampment. This was for information purposes, as the Department Council will act on the budget at its post-Encampment meeting.

28. Commander Lafferty stated the Department needed to establish the Department per capita for 2014. The current per capita is \$4.00. PDC Thomas Schmidt moved the Department per capita remain at \$4.00 for 2014. Motion was seconded and passed.

29. Secretary Russ was recognized and requested Commander Lafferty turn the gavel over to SVDC Bartlow. SVDC Bartlow then recognized Secretary Russ. Secretary Russ presented a nomination from himself and PDC James Knopke that PDC Thomas E. Schmidt and PDC Roy A. Lafferty both be awarded Emeritus status at the conclusion of this Encampment. Motion carried.

30. SVDC Bartlow then returned the gavel to Commander Lafferty.

31. PCC Lane Smith, Camp 5, was recognized and mentioned the sesquicentennial of the Battle of Westport was being scheduled for October 23 and 24, 2014. He wants to be sure the SUVCW is involved.

32. CinC Mellor was granted the floor for the purpose of addressing the Encampment. He gave an update on the medical status of PCinC/National Quartermaster Danny Wheeler, the changes for the Gettysburg Remembrance Day event, signature events, and very favorable comments on the Department of Kansas Encampment.

33. There being no more new business to come before the Encampment, Commander Lafferty proceeded with the nominations and election of officers.

34. At this time, Commander Lafferty asked the Nominating Committee to present its report. PDC Alan L. Russ presented the report. [Page C-2]

35. Commander Lafferty then placed the recommendations of the Nominating Committee into nomination for their respective positions, and officially discharged the Nominating Committee with a "Thank you" from the Department. Those nominated were:

36. There were no motions from the floor to nominate any additional candidates, and PDC Randal Durbin moved nominations be closed. Motion was seconded and passed.

37. The Department Secretary read the names of those nominated for office. Those brothers were then submitted as candidates for the offices indicated:

38. Paul Jefferson moved the nominees be elected by acclamation of the Encampment. Motion was seconded and carried.

39. Commander Lafferty requested a motion from the floor to recognize Corp. Patrick Coyne Camp 1 for all of its efforts in hosting the Encampment. PCC Rocky Barlow moved the request. The motion was seconded and carried.

40. Commander Lafferty requested a motion from the floor to recognize and thank the Emporia Senior Center for providing the meeting facilities. Paul Jefferson, Camp 4, moved for the request. The motion was seconded and carried.

41. Commander Lafferty recognized Secretary Russ, who moved, "The proceedings of this encampment, upon approval by the voting members of the Department Council, and when signed by the outgoing and incoming Department Commander,

shall be accepted as the official proceedings of the encampment, be distributed to the camps of the Department, furnished to the National Headquarters, and be posted on the Department website at that time.” Motion was seconded and passed.

Having stepped into the position of Junior Vice Commander in the fall of 2012, I have only one item to include in my 2012 report. It was shortly after my election that I received from Brother Tad Campbell, Junior Vice Commander-in-Chief, information he received through the national website of a Kansan who had completed a membership application, with appropriate documentation of Union military ancestry. The candidate had paid the required membership application fees.

I immediately e-mailed the candidate, welcoming his membership in the Department of Kansas. I informed him that the Department has four camps, located in Wichita, Topeka, Lawrence, and Olathe, and that he is welcome to join any of these camps. Because he lives in Liberal, and was at that time a member of the Kansas Legislature, I suggested that he might be interested in uniting with Old Abe Camp #16 in Topeka, as he would likely be spending several months in Topeka. The above numbers represent an increase of four in reportable strength. Last year we broke even from the previous year; however, for the two previous years we had a net loss of seven. I know there are several additional new brothers since January 1 who are not included in the above numbers. With continued work by the camps, we may well have turned the corner on the decline in strength.

As Department Secretary I attended the 2012 Fall Council Meeting on October 19, 2012.

It continues to be my honor to serve the Department in this capacity this past year, and I look forward to serving the remaining year of my term of office.

There were seven motions placed before the Department Council via the Electronic Boardroom. These include:

MOTION 1

It is moved the Department provide to the Eagle Scout Coordinator a budget of \$200.00 for the period from May 1, 2012, through January 11, 2013, for the purpose of acquiring supplies to be used by that office, including certificates, mailers, and postage. The Eagle Scout Coordinator will submit receipts for any such purchases to the Department Secretary, at which time reimbursement shall be made. A full accounting of expenditures shall be included in the report of the Eagle Scout Coordinator to the Seventeenth Annual Department Encampment, January 12, 2013.

Motion by Secretary Russ, seconded. All votes having been cast as of May 20, 2012, the motion received 7 votes in the affirmative, 0 votes opposed, and 0 votes not cast.

I am pleased to report that over 27,200 Civil War veterans buried in Kansas have been listed in the SUVCW Graves Registration database, with much credit going to my predecessor, Bob Wandel. Just over 3,000 of the listed veterans served in Kansas units, demonstrating that Kansas indeed became the "Soldier State" following the war as many veterans sought new lives for themselves and their families on the central Great Plains.

I did not gain access to the website as the Department of Kansas Graves Registration Officer (GRO) until several months ago and I did not keep track of how many veterans I entered into the database as the GRO (less than 100?). During my years as an individual contributor to the website, I have personally entered over 2,600 veterans' information from cemeteries across many states.

Please continue to look for opportunities to honor our Boys in Blue by getting markers for unmarked veterans graves (following SUVCW guidelines), replacing illegible or damaged markers, and resetting markers. These are great occasions for your camp to build networks with local historical and genealogical societies, service and veterans' organizations, and youth groups. Doing so lets them know that the SUVCW exists and is an organization that is relevant and ready to partner with them. Grave rededication ceremonies enhance communities and enlighten a new generation to the sacrifices that saved the Union. We can't and shouldn't do it alone. Many hands make for light work, builds goodwill for our organization, and provides opportunities to gain new members.

HISTORIAN

Last year at this time I indicated that the job that pays the bills was cutting into time to work of SUVCW affairs due to cutbacks. I'm afraid that the words that Will Rogers spoke 80 years ago or so have proven prophetic. In a reference to the Great Depression, he said, "They said things can't go on like this, and they were right. They got worse."

But let's not dwell on that. In the past year I did respond to a few inquiries that came my way, and made some minor progress on the projects entrusted to me. Knowing from experience that often research projects are never really finished, I am still setting a goal of putting the Last Soldier Project and inventory of G.A.R. records in some usable form by the fall of 2014, if not sooner. There are a few reasons for this, and in doing so, I'm obviously talking about the future, rather than the past year.

For starters, at the job that pays the bills you are going to see me make a gradual switch to another war. The centennial of the First World War is coming up, and it is our hope that we will be doing a few things, including working with other organizations in marking this observance.

Before that happens, there will be a Civil War exhibit at the Kansas Museum of History to mark the closing of the sesquicentennial of the war. This exhibit is tentatively scheduled to run October 3, 2014 until May 24, 2015. It has been suggested that this need only be an exhibit of the battle flags, and many of you know that would be near and dear to my heart (At the close of the exhibit I believe I will have been working toward the conservation of the flags for 20 years.)

I would, however like to see a little more to the exhibit. In my mind at this point the tentative title for the exhibit is "The Great Soldier State," and it certainly will include battle flags, as well as information about Kansas troops in the war. But because the Historical Society and the G.A.R. once shared the Memorial Building in Topeka, and an arrangement was made for the Historical Society to absorb the G.A.R. collections into the Society

collections, there are many items that have nothing to do with battles and aspects of the war that involved Kansas troops.

It might be a tad ambitious, but this exhibit should also include something about the post-war settlement of Kansas that made this the "Great Soldier State." With that, I will be asking for the use of the Monuments and Memorials pages and the G.A.R. Post page on the Kansas SUV CW website for possible use at computer terminals in the gallery.

We'll hope this proves to be a success!

ATTACHMENT C – COMMITTEE AND OTHER REPORTS

2012 NATIONAL ENCAMPMENT

The 131st National Encampment was held on August 10 and 11, 2012, in Los Angeles, California. For the first time since the Department of Kansas was re-established in 1996, we did not have a representative at the National Encampment.

I previously reported to the camps a summary of changes to the National Constitution and Bylaws. The amendment to the Constitution will be addressed under “new business.”

One significant change was the restructuring of the Life Member program.

The wearing of badges of the organization was addressed, with a change that was made only a few years ago being reversed. A brother may no longer wear all of the Class B badges to which he is entitled, but may only wear one of them. Class B badges include the Past Camp Commander Badge, Past Department Commander Badge, and Past Commander-in-Chief Badge.

Wearing of National and Department Encampment badges was clarified. A brother who has attended a National Encampment may wear that badge until the next National Encampment. Likewise, if the Department Bylaws provide for it, a brother who attends a Department Encampment may wear that badge until the next Department Encampment, provided the Department Bylaws allow it. One of the amendments to our Bylaws which is being presented today does just that.

I encourage as many of you who can to attend the 132nd National Encampment on August 9 and 10, 2013, in Milwaukee, Wisconsin. I will be attending, and I sincerely hope others will be able to.

BYLAWS COMMITTEE

The Department Bylaws Committee, consisting of the Department elected officers and Immediate Past Department Commander, convened on October 20, 2012, in conjunction with the Fall Council Meeting. The committee reviewed six proposed amendments, as shown below. A summary of the amendments, the amendments, and a marked-up copy of the Department Bylaws was distributed to all camps on October 26, 2012, in accordance with the Bylaws.

AMENDMENT 2012-01

This amendment changes the name of the “Corporal Leonidas B. Davis Award for Recruiter of the Year” to “Corporal Leonidas B. Davis and PDC Dean K. Speaks Award for Recruiter of the Year” and establishes the “John Clem Award for Accomplishments by a Junior Member or Junior Associate” as a permanent award of the Department.

The Davis award was originally established by then Department Commander Dean K. Speaks in 1996 and first awarded in 1997. It was named after Bro. Speaks’ Civil War ancestor. In the desire to honor PDC Speaks, the brother who was the driving force in establishing the original camps in Kansas and getting the Department of Kansas re-established in 1996, it was felt this was the appropriate way to do so.

The John Clem award was established by Department Commander Roy A. Lafferty in 2012 and was first awarded that year. It provides the only means of honoring a Junior Member or Junior Associate by the Department Commander. The award may be awarded to more than one person per year and at times other than the Department Encampment.

COMMITTEE RECOMMENDATION: The committee recommends adoption of this amendment.

AMENDMENT 2012-02

This amendment modifies the preamble of the Department of Kansas Bylaws to clarify the Marine Corps as a distinct service during the Civil War and to include the Revenue Cutter Service. An amendment to the National Constitution is also out to the Departments for ratification to change the preamble of the Constitution. The National Constitution and Regulations are in full agreement with the proposal.

COMMITTEE RECOMMENDATION: The committee recommends adoption of this amendment.

AMENDMENT 2012-03

This amendment removes Department Rules, Regulations, and Policies from being included in the Department Bylaws by reference. Per National Regulations, changes to Department Bylaws are not effective until approved by the Commander-in-Chief. If policies and such are included by reference, they are, in effect, part of the Bylaws, and any changes to them could not go into effect until approved by the CinC. (See National General Order No. 5) This amendment leaves control of the rules, regulations, and policies under the sole control of the Department so long as they do not conflict with the National Constitution or Bylaws.

COMMITTEE RECOMMENDATION: The committee recommends adoption of this amendment.

AMENDMENT 2012-04

This amendment empowers to the Department Council to approve and issue a Department Encampment Badge for Department Encampments. It sets out the policy for selling and distributing the badge. The amendment also both permits and restricts the wearing of the Department Encampment Badge per the National Regulations of the Order.

COMMITTEE RECOMMENDATION: The committee recommends adoption of this amendment.

AMENDMENT 2012-05

This amendment directs that Camps are not required to pay annual Department dues for Junior Members and Junior Associates. It is still up to the camp to decide what amount of dues the camp wishes to charge the Junior Members and Junior Associates of their camp. If approved, this amendment will be effective beginning 2014.

COMMITTEE RECOMMENDATION: The committee recommends adoption of this amendment.

AMENDMENT 2012-06

This amendment removes the process of camps submitting proposals to host a Department Encampments. It also removes the process for the Council to solicit for a host camp. With this amendment, the Department of Kansas is the "host" of the Department Encampment at a location set by the Department Council. This amendment does not prevent a camp from requesting the Encampment be held in a particular location.

COMMITTEE RECOMMENDATION: The committee recommends adoption of this amendment.

AMENDMENT 2012-01

AN AMENDMENT CHANGING THE NAME OF THE CORPORAL LEONIDAS B. DAVIS AWARD AND ESTABLISHING THE JOHN CLEM AWARD AS A PERMANENT AWARD OF THE DEPARTMENT

CHAPTER VII DEPARTMENT AWARDS

Article III: PERMANENT AWARDS.

The following awards, having been well established within the Department of Kansas by precedent, are established as permanent awards of the Department. These awards, and their criteria, are as follows:

Section A. CORPORAL LEONIDAS B. DAVIS & PDC DEAN K. SPEAKS AWARD FOR RECRUITER OF THE YEAR.

This award may be presented by the Department Commander to the brother who has recruited the most new brothers (Members, Associates, Junior Members, and Junior Associates) since the previous Department Encampment. The determination of which brother is to receive credit for a new brother is based upon the name entered on the application for membership as “Recommended by SUVCW Brother.” Applications received from the National Junior Vice Commander-in-Chief are not considered when determining the number of “recruits.” The Department Commander may determine not to present the award any year he feels no one has recruited enough brothers to set him apart in this regard.

Section B. CAPTAIN PATRICK H. CONEY AWARD FOR BROTHER OF THE YEAR.

This award is presented by the Department Commander to the brother whom the Department Commander has determined to have performed significant service to a camp or the Department within the past year. The Department Commander shall seek recommendations from the various Camp Commanders for this award.

Section C. LEANDER STILLWELL OUTSTANDING ACHIEVEMENT AWARD.

This award may be presented by the Department Commander to the brother who has performed significant service to the Department of Kansas or the organization as a whole over an extended period of time. The Department Commander may seek recommendations from Camp Commanders, Department Officers, Past Department Commanders, and others. This award is neither required nor expected to be awarded each year.

Section D. WILLIAM W. NIXON AWARD FOR CAMP OF THE YEAR.

This award is presented by the Department Commander to the camp within the Department which demonstrated the greatest degree of support to the goals and ideals of the Sons of Union Veterans of the Civil War in such areas as community involvement, memorial ceremonies, public education, conduct of camp meetings, and such. The Department Commander shall seek recommendations from the various Camp Commanders for this award.

Section E. JOHN CLEM AWARD FOR ACCOMPLISHMENTS BY A JUNIOR MEMBER OR JUNIOR ASSOCIATE.

This award is presented by the Department Commander to a Junior Member or Junior Associate within the Department for noteworthy accomplishments by that brother. This award may be presented to more than one brother during the year. It may be presented by the Department Commander at times other than the Department Encampment. Camp Commanders are encouraged to notify the Department Commander of Junior Members or Junior Associates within their camp whom they feel are deserving of this award.

Section. B. APPROVED ACTIONS OF DEPARTMENT ENCAMPMENTS.

1. All actions approved by a Department Encampment shall be effective upon publishing of the official proceedings of the Department Encampment.
2. Actions approving changes to the Bylaws of the Department of Kansas shall be effective per Chapter IX, Article III, of these Bylaws.
3. Actions by a subsequent Department Encampment may rescind or repeal an action of a previous Department Encampment.

AN AMENDMENT AUTHORIZING DEPARTMENT ENCAMPMENT BADGES

**CHAPTER IV
DEPARTMENT ENCAMPMENTS AND MEETINGS**

Article I: DEPARTMENT ENCAMPMENTS

Section L. DEPARTMENT ENCAMPMENT BADGE.

1. The Department Council shall have the authority to determine that a Department Encampment Badge shall or shall not be issued for an encampment. If an encampment badge is to be issued, the Department Council shall review and approve a design for a suitable Department Encampment Badge. Such badge shall contain appropriate encampment information on it and be suspended from a ribbon drape.
2. All Brothers of the Department of Kansas, SUVCW, who are encampment attendees shall be permitted to purchase the badge at the Encampment at a reduced rate determined by the Department Council. Likewise, all Sisters of a Department of Kansas Allied Order of the Grand Army of the Republic who are in attendance when their encampment is held in conjunction with the SUVCW, will be permitted to purchase a badge at the Encampment for the reduced rate. Remaining encampment badges may be sold at the conclusion of the Department Encampment, first to SUVCW and Allied Order encampment attendees, and then, to other brothers of the Order as a souvenir, at the full price as determined by the Council.
5. An encampment attendee is permitted to wear the Department Encampment Badge in accordance with National Regulations of the Order as a Class D Badge until the next Department Encampment. Those who did not attend the encampment, but purchased the badge as a souvenir, are not permitted to wear the encampment badge.
6. Any brother entitled to wear the Department Encampment Badge who attends a National Encampment of the SUVCW during the period he is entitled to wear the Department Encampment Badge, is authorized to wear the badge at the National Encampment.
