**PROCEEDINGS OF THE EIGHTEENTH ANNUAL ENCAMPMENT
DEPARTMENT OF KANSAS

January 11, 2014
Emporia, Kansas**

1. As required by Chapter II, Article III, Section 1 of the Regulations of the Sons of Union Veterans of the Civil War and by Article VI, Bylaws of the Department of Kansas, SUVCW, the Seventeenth Annual Encampment of the Department of Kansas, was held on January 11, 2014, at the Emporia Senior Center, Emporia, Kansas.
2. The Encampment was called to order at 10:05 AM by Department Commander Rocky L. Bartlow. At that time, the Past Department Commanders in attendance were announced and filed into the room. A vacant chair remained in memory of PDC Dean K. Speaks and PDC Kenneth D. Strader.
3. Commander Bartlow received our honored guest, Past National Commander-in-Chief D. Brad Schall, Department of California & Pacific, who was representing National Commander-in-Chief Ken L. Freshley. Brother Schall was presented a gold encampment badge by Commander Bartlow. Brother Schall gave brief personal greetings to the Encampment.
4. At 10:10 AM, Commander Bartlow officially opened the encampment. The opening was conducted per the Rituals and Ceremonies of the Order.
5. The Department Secretary called the roll of officers, and reported all officers present:

6. The Chaplain's prayer and the Pledge of Allegiance followed.
7. Commander Bartlow then declared the Eighteenth Annual Encampment of the Department of Kansas, Sons of Union Veterans of the Civil War, to be open for the transaction of such business as may legally and properly come before it.

14. Secretary Russ reported the all correspondence which had been received has previously been distributed to all officers and camp secretaries.
15. Commander Bartlow noted there was no unfinished business from the Seventeenth Encampment.
16. Commander Bartlow then called for Committee and other reports.
17. The following committee reports were presented and accepted by the Encampment as written:

 - c. Commander Bartlow declared that the Nominating Committee report was to be held until the start of the nomination process.
 - d. PDC James R. Knopke, Department Council member, presented a report as to the satisfactory state of the funds of the Department. [Page C-2]
18. At 11:45 AM, Commander Bartlow directed the Chaplain to close the Bible. Commander Bartlow then declared a recess for lunch. The Encampment was reconvened at 12:55 PM, moving to "New Business."
19. At 1:05 PM, Commander Bartlow again declared a brief recess so he, PCinC Schall, and the other department officers could pay a visit to the Department of Kansas Ladies of the Grand Army of the Republic. The encampment was reconvened at 1:15 PM.
20. There were no items assigned to the Encampment Bylaws Committee or the Encampment Resolutions and Officer Reports committee.
21. Commander Bartlow requested to know which past department commanders planned to attend the 2014 National Encampment in Marietta, Georgia. Commander Bartlow stated he would be attending in the status of Department Commander, if reelected. Secretary Russ and PDC Lafferty stated they will be attending in their capacity as PDC.

22. Commander Bartlow stated the Department of Kansas was presumed to be entitled to six delegates to the National Encampment. The actual number will be determined when the annual report is filed in April. Commander Bartlow asked for nominations from the floor for the election of delegates to the 133rd National Encampment. 23. The motion for election of delegates was seconded and approved. These brothers will be so indicated on the Form 49 submitted to National Headquarters.

24. Commander Bartlow recognized PDC Russ, who moved, "All Members and Associates of the Department of Kansas who are in good standing as of this date (January 11, 2014) and are not otherwise entitled to membership at the 133rd National Encampment nor elected as a "Delegate" to the 133rd National Encampment shall be elected as "ALTERNATE DELEGATES" to the 133rd National Encampment of the Sons of Union Veterans of the Civil War, August 15-16, 2014, in Marietta, Georgia. A listing of those so elected as Alternate Delegates shall be included in the official proceedings of this encampment and shall be attached to the Department of Kansas Certificate of Election and Installation of Department Officers (SUVCW Form 49) and forwarded to the National Headquarters." Motion was seconded and passed. [Page F-5]

25. Commander Bartlow announced that, per the Department Bylaws, the 19th Annual Encampment of the Department of Kansas would be on January 10, 2015. Commander Bartlow entertained a motion that the encampment be hosted by the Department at large. Motion by PDC Randal Durbin was seconded and passed.

26. Commander Bartlow called upon Treasurer Russ to present discussion on the proposed budget for 2014. Copies had been distributed to the members of the Encampment. This was for information purposes, as the Department Council will act on the budget at its post-Encampment meeting.

27. Commander Bartlow stated the Department needed to establish the Department per capita for 2015. The current per capita is \$4.00. PCC Kent Melcher moved the Department per capita remain at \$4.00 for 2015. Motion was seconded and passed.

28. PCC William Fischer advised the encampment of the Kansas City Public Library's website featuring the "Civil War on the Western Border."

29. PCinC Schall, at this time, presented greetings from CinC Ken Freshley. Afterward, the Department presented PCinC Schall with a gift of delegate medal from the 1910 GAR Department Encampment which was held in Hutchinson, Kansas.

30. There being no more new business to come before the Encampment, Commander Bartlow proceeded with the nominations and election of officers.

31. At this time, Commander Bartlow asked the Nominating Committee to present its report. PDC Alan L. Russ presented the report. [Page C-1]

DEPARTMENT COMMANDER REPORT

Rocky L. Bartlow, PCC

The Department of Kansas recently changed our by-laws to move our Department Encampment from April to January. This was the first year for that change and I had the privilege of being elected Department Commander in January for a one-year term. We were also privileged to have Commander-in-Chief Mellor and ASUVCW Senior Vice President Diane Mellor in attendance and swearing in our department officers.

During my term I have focused on several goals including promoting activities that help camps cooperate together as a department and making the SUVCW relevant to the next generation by doing things that draw in young people and encourage them to participate in camps. I would like to see Kansas be the Department with the highest number of juniors in the nation. To that end, we have continued the use of a Vision Committee, first started by PDC Roy Lafferty during his term, and formed of brothers of several camps. We met several times and worked to come up with ideas promoting the goals stated above. The committee stopped meeting for the summer due to scheduling constraints and then there was a temporary recruiting halt on juniors due to desire from national to get a handle on how to properly protect young people and the order in light of the Sandusky episode and so issued GO 6. We owe it to the youth we work with and to the order to make sure it is handled correctly. We plan to proceed when that is sorted out.

One of our recommendations was to encourage camps to get together for events and one such was a workday at the Black Jack battle site. I encourage camp secretaries to share minutes of their meetings and camp events so that brothers from other camps may participate. One of the best opportunities is joint grave services of which I will note in greater detail later.

Vital to our purpose as a department is the proper commemoration of Memorial Day. To that end, the four camps of the department have participated in multiple events this year including Veterans Memorial Park and two others in Wichita, three cemeteries in Lawrence, and Topeka Cemetery and one other in Topeka. The list is not exhaustive. We also field requests for helping with replacement cemetery markers and perform ceremonies for families, which sometimes requires hours of driving to attend. The Department currently has several requests for help in researching ancestors, obtaining headstones, and performing ceremonies for soldiers. Kansas, as the Soldier's State due to the myriad of soldiers who came here after the war, has many Civil War soldiers so it presents a daunting task in properly recording and honoring those great soldiers and sailors. We consider it one of our highest honors to do that so that they may receive the due owed to the honored dead of our country.

Along that line was a notable event, the Crooms memorial service in Hutchinson, attended by brothers from several camps, most coming quite a distance. It was encouraging to see the department brothers work together to make sure a boy in blue wasn't forgotten. The event was attended by Mr. Crooms family and PCinC Brad Schall whose ancestor was a GAR camp brother of Mr. Crooms. I was unable to be in attendance but was extremely proud to receive PCinC Schall's card of thanks, commending the brothers of the department for doing their honorable duty. It was one of the high points of the year and spoke well of our brothers.

The brothers of the department are also busy with making the department known at many community events including gun shows, genealogy seminars, and military and patriotic events. We use these opportunities to show various historical items, help visitors find their Civil War ancestors, pass out information and membership applications, and discuss the Civil War in general. We have found these events to be profitable in generating new members.

Our camps also are careful to remember those who currently serve our country in providing items requested by them including calling cards so they can stay in contact with their families.

I was able to attend the 2013 National Encampment in Milwaukee, WI and the Department of Kansas Fall Council meeting and am looking forward to attending the 2014 encampment in Marietta, GA.

In conclusion, I believe for the SUVCW to be relevant in the next years, we must engage the youth of our culture and continue our primary task of making sure the Union soldier isn't forgotten. It is my hope

that the abovementioned challenge represented in GO 6 will be soon addressed and we can move forward drawing in new blood so we can continue the primary task. The Boys in Blue simply must not be forgotten.

The proceedings of the 17th Annual Department Encampment, January 12, 2013, were properly published and were approved by the full Department Council. Electronic copies were furnished to each Department Officer and Camp Secretary. They are also available on the Department website at www.suvcwks.org under the "Official Documents" section.

The above numbers represent an increase of four in reportable strength. Last year we also had a net increase of four. I know there will be several additional new brothers since January 1 who are not included in the above numbers. With continued work by the camps, we may well have turned the corner on the decline in strength.

MOTION 1

The Seventeenth Annual Department Encampment approved the following motion concerning the Department Encampment Proceedings: "The proceedings of this encampment, upon approval by the voting members of the Department Council, and when signed by the outgoing and incoming Department Commander, shall be accepted as the official proceedings of the encampment, be distributed to the camps of the Department, furnished to the National Headquarters, and be posted on the Department website at that time." By Direction of 17th Department Encampment. All votes having been cast as of February 15, 2013, the motion received seven votes in the affirmative, 0 votes opposed, and 0 votes not cast.

GRAVES REGISTRATION OFFICER

We continue to make progress in locating our Boys in Blue who eternally rest in the Sunflower State. There are 28,213 Civil War veterans' Kansas gravesites listed in the national SUVCW Graves Database (as of 29 Dec 2013). This is an increase of more than 1000 over last year's report. Since gaining access to the Kansas GRO account late in 2012, I have added 335 Kansas gravesites. I continue to enter gravesites outside of the state through my personal user account, which now totals 2796 entries, roughly 200 more than reported last year. While not a large number of new graves added, I try to be as thorough as possible and include as much information as possible, which can prove time consuming. Many existing entries are unnecessarily bare bones, and I have added information such as birth/death dates and enlistment/discharge dates to dozens of Kansas graves; doing so doesn't add to the tally but is just as important.

I have spent much time this year trying to locate the graves of members of the 24th KS Militia. Roughly 1000 men was mobilized and activated for much of October 1864 to assist in the defense of Fort Scott and SE Kansas during Price's Confederate advance through Missouri. These men have been overlooked because of their short service as reservists but they have earned inclusion in the database. Since they were generally not members of the GAR, their service not listed in KS state censuses, were non-recipients of government pensions, and their headstones don't indicate military service, these boys have been difficult to track down. So far, I have located just over 110 of their graves, some as far away as California and Washington state.

I was fortunate to spend time with SUVCW GRO Bruce Frail at the National Encampment in Wisconsin this past August. Brother Frail was able to clarify some questions I had, as well as share his vision for future database improvements. The SUVCW continues to work with the VA to seek resolution for the next-of-kin requirement for headstone requests, which hampers our ability to honor our fallen.

One particular highlight of the year was assisting Ms Janice Lovelace of Seattle in obtaining a VA headstone for her great-grandfather's unmarked grave in Eastside Cemetery, Hutchinson. Private John Crooms, born enslaved in Kentucky, served in the 5th US Colored Cavalry. Coyne Camp No. 1 did a great job conducting a memorable dedication service for Ms Lovelace, who was able to attend. The Hutchinson newspaper also provided good coverage of the event. Huzzah to all involved – this is what our Order is all about!
