PROCEEDINGS OF THE NINTH ANNUAL ENCAMPMENT DEPARTMENT OF KANSAS SONS OF UNION VETERANS OF THE CIVIL WAR April 23, 2005

Lawrence, Kansas

- 1. As required by Chapter II, Article III, Section 1 of the Regulations of the Sons of Union Veterans of the Civil War and by Article VI, Bylaws of the Department of Kansas, SUVCW, the Ninth Annual Encampment of the Department of Kansas, was held on April 23, 2005, at the Watkins Museum of History, Lawrence, Kansas.
- 2. The Encampment was called to order at 1:48 PM by Department Commander Thomas E. Schmidt. The opening ceremony was conducted per the Rituals and Ceremonies of the Order.
- 3. The roll call of officers was conducted with the following officers present or accounted for:

- 4. The Encampment received visiting National Council of Administration member Robert Petrovic, PDC, Department of Missouri. PDC Petrovic delivered greetings from the Commander in Chief and informed us of the addition of Eagle Scout certificate information to the National website and the addition of a Patriotic Instructor handbook and brochures to the National website. Also, he reminded the Encampment that the National graves registration database is now on-line on the National website. Also, PDC Petrovic informed us that all of the Allied Orders of the G.A.R. will be meeting with the SUVCW National Encampments in 2006 and 2007.
- 5. Commander Schmidt informed the Encampment of "housekeeping rules" to be used during the meeting.

- 7. The following camp reports were presented and accepted by the Encampment as written:

 - Joseph Gaston Camp 3 Presented by Dean K. Speaks, PDC: Camp is in the process of reorganization. Meeting will be held on May 7, 2005, in Beloit to initiate new members and conduct election of officers.
 - Old Abe Camp 16 Presented by Camp Commander Randal L. Durbin [ATTACHMENT L]
 - Sgt. Samuel J. Churchill Camp 4 Presented by Camp Commander Roy Lafferty [ATTACHMENT M]
- 8. Reading of incoming correspondence was conducted by the Department Secretary. The correspondence all concerned nominations for National office. The Department Secretary will provide copies of the correspondence to all from the Department who will be attending the National Encampment.
- 9. The following committee reports were presented and accepted by the Encampment as written:

Last Soldier Project – Blair D. Tarr [ATTACHMENT O] 2004 National Encampment – James R. Knopke, PCC [ATTACHMENT P] Nominating Committee report – Kenneth R. Spurgeon, PDC [ATTACHMENT Q]

- 10. The Encampment took a brief recess from 2:45 PM until 3:05 PM. During this time, the Department Commander, Department Officers, and Past Department Commanders present called upon the Ladies of the G.A.R. Encampment occurring elsewhere in the building. Department Commander Schmidt presented the president of the LGAR with a "love" gift. The LGAR Emma Edmonds Circle 2000 presented Commander Schmidt with a gift of a check for \$50.00, to be used to defray the costs for the Department of Kansas Flag and accessories.
- 11. Commander Schmidt announced that the following people had stated intent to attend the 2005 National Encampment: PCC Thomas E. Schmidt, Camp 1 (as PDC); PDC Alan L. Russ, Camp 16; PCC James R. Knopke, Camp 16 (as Department Commander); and Roy A. Lafferty, Camp 4. Commander Schmidt asked if anyone else was also planning to attend. PCC Craig A. Sundell, Camp 4, stated that he was hoping to be able to attend. PDC Franklin L. Bergquist, Camp 1, moved that that Brothers Lafferty and Sundell should be declared delegates to the Encampment. Motion was seconded and carried.

- 12. Commander Schmidt announced that, per the Department Bylaws, the 10th Annual Encampment of the Department of Kansas would be on April 22, 2006. Also, per the bylaws, the camp next in line to host the Encampment is Old Abe Camp 16, Topeka. Commander Schmidt asked Camp Commander Randal L. Durbin of Old Abe Camp 16 if the camp was willing to accept the hosting of the Encampment. Commander Durbin replied that Topeka will be the host camp.
- 13. Secretary Alan L. Russ, PDC, presented the proposed "Policy for Declaring a Period of Mourning Within the Department of Kansas." Secretary Russ stated that the proposed policy had been electronically transmitted to all Department Officers, Camp Commanders, and Camp Secretaries for review. He then explained the contents of the policy to the Encampment. PCC Craig A. Sundell, Camp 4, moved that the policy be approved as written. Motion was seconded and carried.
- 14. Commander Schmidt discussed the newly constructed bridge at Mine Creek Battlefield, along with the need to name the bridge. This is the bridge substantially purchased with funds donated by the Department of Kansas. Also, on April 16, 2005, members of the Department constructed the bridge at the battlefield. The Mine Creek Battlefield Foundation granted naming rights for the bridge to the Department of Kansas in acknowledgement of the funds and labor provided. A bronze plaque will be placed next to the approach to the bridge showing the name of the bridge and the participation of the Department of Kansas in its construction. Commander Schmidt asked for suggestions for naming the bridge. Suggested names from the members of the Encampment included:
 - "Lt. Col. Bazel Lazear" (Commander, 1st Mo. SM)
 - "Lt. Col. Frederick Benteen" or "Lt. Col. F. W. Benteen" (Brigade Commander, his forces fought in the area where the bridge was erected.)
 - "Dedicated to Unknown Dead"
 - "James Dunlavy¹ & Cavalry M. Young²" (Medal of Honor Recipients)

Motion was made by PDC Franklin L. Bergquist, Camp 1, to name the bridge in honor of Lt. Col. Benteen. Motion was seconded and carried.

- 15. Secretary Russ stated that he had received two price quotes for the bronze plaque. One quote was for \$265.00 plus shipping costs. The other quote was from Degginger Foundry, a Topeka company for \$200.00, with no shipping involved. Richard Schrader, Camp 4, moved to have the plaque made by Degginger Foundry. Motion was seconded and carried.
- 16. Secretary Russ presented a sample plaque layout with proposed wording as follows:

Dedicated to the Memory of Those Who Served to Preserve the Union During the Civil War, 1861-1865

This bridge was donated by the Department of Kansas, Sons of Union Veterans of the Civil War.

It is provided to allow visitors a greater access to the battlefield, in particular, the main ford of Mine Creek.

The consensus of the Encampment was to modify the wording to state, "This bridge was donated <u>and installed</u> by the Department of Kansas, Sons of Union Veterans of the Civil War <u>in April</u> <u>2005</u>."

17. Commander Schmidt announced that the Department was actively pursuing the establishment of three new camps within the Department. The expected locations are Olathe, Mine Creek Battlefield (including Pleasanton and Ft. Scott), and Hutchinson.

PCC Craig A. Sundell, Camp 4, provided that he and other members of Camp 4 had set up a recruiting booth in Olathe on April 16, 2005, at the Mahaffie Stage Coach Stop and Farm Historic Site reenactment. They had 26 people sign up for further information. PCC Sundell and the Department will be pursuing formation of a camp in the near future. Commander Schmidt stated that Arnold Schofield and Dr. John Spencer of the Mine Creek Battlefield Foundation had recently joined the Department as Members-at-Large. Both are actively interested in forming a camp at Mine Creek. Also, Commander Schmidt announced that PCC Douglas E. McGovern, Camp 1, will be working on forming a new camp at Hutchinson, where he lives.

Michael Hadl, Camp 4, mentioned that there was also interest in the Miami county area. He is hoping that Camp 4 will try to hold one of its monthly meetings in that area in the interest of attracting support for a new camp in the area.

- 18. Commander Schmidt announced that the Department was wanting to bid on holding the National Encampment in the Department of Kansas during either 2008, 2009, or 2010. A brief discussion followed. A motion was made by PDC Dean K. Speaks to bid on holding the National Encampment in either 2008, 2009, or 2010. Motion was seconded and carried. Secretary Russ was directed to prepare and submit a formal request to the National Encampment Site Selection Committee for consideration.
- 19. There being no more new business, the Encampment proceeded to the election of officers. The Department Secretary read the names of those recommended by the Nominating Committee, said report having been accepted by the Encampment. The brothers were asked by Commander Schmidt if they accepted the nomination and were willing to fulfill the duties of the position. Those brothers were then submitted as candidates for the offices indicated:

Commander Schmidt then asked for additional nominations from the floor of the Encampment. No further nominations were submitted. PDC Franklin L. Bergquist, Camp 1, moved that nominations be closed. Motion was seconded and carried. Nominees were elected by acclamation of the Encampment.

- 20. Commander Schmidt requested a motion from the floor to recognize Sgt. Samuel J. Churchill Camp No. 4 for all of its efforts in hosting the Encampment. PDC Dean K. Speaks so moved. The motion was seconded and carried.
- 21. At this time, Commander Schmidt presented the following awards to the indicated recipients:

Captain Patrick H. Coney Award for Member of the Year PCC Douglas E. McGovern, Camp 1

The Leander Stillwell Outstanding Achievement Award was not awarded this year.

- 22. There being no further business before the Encampment, Commander Schmidt turned over the gavel to PDC Petrovic, who acted as installing officer.
- 23. PDC Petrovic thanked Commander Schmidt for his service on behalf of the Department and presented him with the Past Department Commander badge.
- 24. Incoming commander, James R. Knopke, was asked to provide a list of appointed officers to the secretary. The secretary read those so appointed, to wit:

25. PDC Petrovic then proceeded to install the new Department Officers, after which the new officers were instructed to assume their respective stations. The gavel was then presented to incoming Department Commander James R. Knopke.

- 26. The Department flag was then transferred by the Color Guard from outgoing Commander Schmidt to incoming Commander Knopke.
- 27. Commander Knopke then proceeded to close the Encampment, as per the Ritual of the Order. The Encampment was declared closed at 4:20 PM.



Clyde M. (Cy) Reiter, Joseph Gaston Camp 3, Beloit. Died September 14, 2004

Clyde Melford Reiter was born March 19, 1907 in his family home east of Beloit, the son of John H. and Amanda Ringer Reiter. He died Monday, September 13, 2004 at the Salina Regional Health Center in Salina, Kansas at the age of 97 years.

Cy, as he was known, attended the Second Ward School, and graduated from Beloit High School in the class of 1926.

On May 16, 1929, Cy was united in marriage to Grace Coburn at the United Brethren Parsonage in Beloit. One daughter, Jean, and one son, Tom, were born to that union. After their marriage, the couple lived in Beloit until 1942, when they moved to Wichita, and in 1973, they returned to Beloit to spend their retirement. They had been privileged to spend nearly 69 years of married life together.

From 1932 to 1942, Cy worked at the Beloit Milling Company. He served 30 accident-free years as a bus driver for Continental Trailways, before retiring at the age of 66. Cy enjoyed his retirement by remodeling the home in which he lived until his death. He also enjoyed spending his time with his cousin and good friend, Jim Reiter, as well as traveling on the many bus trips provided by the local banks. Cy was also a sports fanatic, and followed KU basketball and K-State football.

Cy was a member of the Elks Lodge, the United Transportation Union, the NCK Genealogical Society, the Sons of the Union Vets of the Civil War, the Beloit Night Lions Club, was a contributor to the Mitchell County Historical Society, was the Mitchell County Chairman for the American Red Cross, and served as a municipal judge for many years.

Kansas Civil War Memorial/Monument Catalog



Accordingly, a draft website stub has been constructed for Department review. It currently contains listings for 12 monuments. When approved, this will include information on all identified Kansas monuments.

The search and cataloging of monuments has progressed well with contributions from a number of brothers. Forty five monuments and memorials have been identified, located, photographed and logged into the master data base. An additional 65 are listed but research, photography, and/or logging in have not as yet been completed. Forty four Kansas counties (of the total of 105) do not have any monuments currently identified.

SUV Bridge at Mine Creek

At the 2003 Department of Kansas Encampment in Wichita the membership was informed that the State of Kansas was to erect a monument to the veterans of the Battle of Mine Creek on the battlefield. We were told the Sons of Confederates had raised over \$ 2000 for their monument and we had only a short period of time to raise funds for a monument to Union soldiers. The membership quickly raised over \$ 2000 for our share of the project.

We were next informed the State was not going to allow private groups to erect their respective monuments and the Department was left with the dilemma of what to do with the money we had raised. The membership has always been interested in assisting the site in its efforts to interpret the battle and enhance the trails to give visitors a more convenient means of walking over the battlefield and seeing some of the more important points on the field that were very difficult to reach. With the cancellation of the monument, a committee was formed and it was decided to use the funds towards this end. In conferring with Dr. John Spencer, the President of the Mine Creek Foundation Board, it was determined that the greatest obstacle for visitors at the site was the trail from the museum to the main ford used during the battle. A deep ravine cuts across the path and a temporary plank with steep steps were the only means to cross this area. A small arch bridge spanning the ravine would allow foot traffic, small equipment and handicap access to the main ford. Dr. Spencer located a company in Canada that makes custom bridge kits. After giving this company our specifications a bridge was ordered and it should arrive soon.

A workday was scheduled for Saturday, April 16th. The footings were poured and construction took place that day. Nine members of the Kansas Department assisted in this project. A plaque commemorating the SUV's contribution to this project will be attached to the structure and a dedication ceremony is planned for June 25th. This project will go a long way to enhance the visitor's experience at Mine Creek.
