PROCEEDINGS OF THE TWENTIETH ANNUAL ENCAMPMENT DEPARTMENT OF KANSAS

SONS OF UNION VETERANS OF THE CIVIL WAR

January 9, 2016 Salina, Kansas

- 1. As required by Chapter II, Article III, Section 1 of the Regulations of the Sons of Union Veterans of the Civil War and by Article VI, Bylaws of the Department of Kansas, SUVCW, the Twentieth Annual Encampment of the Department of Kansas, was held on January 9, 2016, at the Church of the Cross UMC, Salina, Kansas.
- 2. The Encampment was called to order at 10:10 AM by Department Commander Kent M. Melcher. At that time, the Past Department Commanders in attendance were announced and filed into the room. A vacant chair remained in memory of PDC Dean K. Speaks and PDC Kenneth D. Strader.
- 3. Commander Melcher received our honored guest, National Commander-in-Chief Eugene Mortorff, Department of the Chesapeake. Commander Mortorff gave a brief personal greeting to the Encampment.
- 4. At 10:20 AM, Commander Melcher officially opened the encampment. The opening was conducted per the Rituals and Ceremonies of the Order.
- 5. Commander Melcher then welcomed the members in attendance from the newest camp in the Department Humboldt Camp Number 9, Humboldt, Kansas.
- 6. Commander Melcher then declared the Twentieth Annual Encampment of the Department of Kansas, Sons of Union Veterans of the Civil War, to be open for the transaction of such business as may legally and properly come before it.
- 7. The Department Secretary called the roll of officers, and reported all officers present:

Secretary/Treasurer and Counselor Alan L. Russ, PDC, Camp 7, present.

Council Member James R. Knopke, PDC, Camp 5, present.

Council Member Roger D. Lester, Camp 16, absent excused.

Council Member and Chaplain Roy A. Lafferty, Camp 4, present.

Patriotic Instructor K. Kirk Nystrom, Camp 16, present

Civil War Memorials Officer Douglas E. McGovern, PCC, Camp 1, absent.

Historian Blair D. Tarr, Camp 16, present

Color Bearer Shawn Bell, Camp 1, present

- 8. The Chaplain's prayer and the Pledge of Allegiance followed, and the Patriotic Instructor then led the Encampment in the signing of the Battle Hymn of the Republic.
- 9. At this time, the Secretary Russ presented the Credentials Committee report of those present at the Encampment. A quorum was declared to be present.
- 10. Commander Melcher appointed PDC Alan L. Russ as Chairman of the Encampment Bylaws Committee, with PDC Rocky L. Bartlow and PDC Roy A. Lafferty as committee member.
- 11. Commander Bartlow appointed PCC Mark A. Britton as Chairman of the encampment Resolutions and Officers' Report Committee, with PDC James R. Knopke and PCC William E. Fischer, Jr. as committee members.
- 12. Commander Bartlow informed the Encampment of "housekeeping rules" to be used during the meeting.
- 13. The Department Officer reports were presented by the officer and accepted by the Encampment as written. No recommendations were included in the reports.
- 14. The camp reports were presented and accepted by the Encampment as written. No recommendations were included in the reports.
- 15. Secretary Russ reported that official correspondence which had been received has previously been distributed to all officers and camp secretaries.
- 16. Commander Melcher then called for Committee and other reports.
- 17. The following committee reports were presented:

- a. Bylaws Committee Report Alan L. Russ, PDC
 - i. Amendment 1, as follows, was presented and approved by two-thirds vote of the Encampment as submitted.

CHAPTER III DEPARTMENT MEMBERS AT LARGE (DMAL).

Section A. AUTHORITY TO ESTABLISH.

In accordance with Chapter II, Article X, Section 1, National Regulations, the Department shall allow Department Members at Large (DMAL).

Section B. MUST FIRST BE ASSIGNED TO CAMP.

Brothers shall be assigned to the DMAL only after the application has first been processed as shown, below. No brother will be placed directly into the DMAL without having first been assigned to a camp for the remainder of the current membership year unless approved by the Department Commander.

Section C. OPPORTUNITY TO SELECT CAMP.

When applications are received from the National Organization for MAL, the Department Junior Vice Commander shall contact the brother and give him the opportunity to select one of the Camps in the Department to join.

Section D. GEOGRAPHIC ASSIGNMENT TO CAMP.

If the new MAL does not elect to choose a Camp, he shall be assigned to the Camp closest to his place of residence.

Section E. DEVELOPMENT OF GUIDELINES.

The Department Council shall develop guidelines for Camp assignment.

Section F. NO ESTABLISHMENT OF DMAL CAMP.

- 1. A separate camp shall not may be established for DMAL. When a DMAL camp has not been established, the The Department Secretary shall be responsible for the administrative requirements concerning brothers assigned to the DMAL.
- 2. Designation of DMAL Camp. Said camp shall be designated as Col. John A. Martin Camp No. 8.
- 3. DMAL Camp Officers. When a DMAL camp has been established, the Department Commander shall appoint a Camp Commander and Camp Secretary/Treasurer for the camp. No other camp offices shall be required for the DMAL Camp. The appointed officers need not be assigned to the DMAL camp.
- 4. No brother may be assigned to the DMAL or DMAL camp if he holds membership in another camp or department.
- 5. The dues for the membership of the DMAL shall be set at the equivalent of the highest camp dues within the department as established by the annual camp reports submitted as of March 31 the previous year.
- ii. Amendment 2, as follows, was presented and approved by two-thirds vote of the Encampment as submitted.

CHAPTER IV DEPARTMENT ENCAMPMENTS AND MEETINGS Article II: OTHER MEETINGS

Section A. FALL COUNCIL MEETING.

The officers of the Department shall conduct the "Fall Council Meeting" each year on the **third**Saturday of October. The location and time for the meeting shall be determined by the Department

Commander, with preference given to locating it at the camp which will be the host camp for the upcoming

Department Encampment. If the meeting must be rescheduled, it should be held as soon as possible after
the originally scheduled date.

- 1. **Purpose.** The Fall Council Meeting shall be for the purpose conducting the routine business of the Department, to include approving expenditures, policies, and procedures. The Department Council will not take actions which are reserved for the Department Encampment. Likewise, any action of the Department Council may be overruled by action of the next Department Encampment.
- 2. **Voting Members.** The elected offices of the Department and the immediate Past Department Commander are the voting members of the Department Council.
 - 3. Non-voting Members.
- (a) All appointed Department Officers are members of the Council, without vote, and should be in attendance.

(b) All brothers of the Department holding the honor of Past Department Commander are members without vote, and, as such, encouraged to attend the meeting.

4. Other Attendees.

- (a) Camp Commanders, or their designated representative, should attend. They should be prepared to report on the activities of their camp. This provides an opportunity for communication between the Department Officers and the camps. Camp Commanders or representatives are attendees without membership on the Council and without vote.
- (b) All brothers of the Department are permitted and encouraged to attend the meeting without voice or vote. Any attendee may request of the Department Commander to present an item to the meeting or to provide discussion or comments on an item being discussed at the meeting. It shall be the decision of the Department Commander as to whether this shall be permitted.

Article III: ELECTRONIC BOARD ROOM

Section A. ESTABLISHMENT OF ELECTRONIC BOARD ROOM.

An electronic boardroom shall be established for the purpose of conducting the business of the Department between the Department Encampments and Council meeting.

Section B. PUBLISHED POLICY REQUIRED.

A Department policy shall be established for the Department Council to submit motions to the Department Commander through approved electronic means, to conduct discussion of such motions through electronic means, to allow the voting members of the Council to electronically cast votes, for the Department Commander to announce the results of the vote, and for the Department Secretary to officially publish the results to the camps in a timely manner.

- b. The Vison committee report was presented by Commander Melcher.
- c. Nominating Committee Rocky L. Bartlow, PDC
- i. Brothers recommended by the Nominating Committee were placed into nomination for the respective office, with nominations from the floor to be taken later.
- ii. Commander Melcher officially discharged the Nominating Committee with the "thank-you" of the Department.
 - d. PDC James R. Knopke, Department Council member, reported as to the satisfactory state of the funds of the Department.
- 18. At 12:00 Noon, Commander Melcher directed the Chaplain to close the Bible. Commander Melcher then declared a recess for lunch. The Encampment was reconvened at 1 PM, moving to "New Business."
- 19. At 1:15 PM, Commander Melcher again declared a brief recess so he, CinC Mortorff, and the other department officers could pay a visit to the Department of Kansas Ladies of the Grand Army of the Republic. The encampment was reconvened at 1:30 PM.
- 20. The Encampment Bylaws Committee reported there were no actions to consider.
- 21. The Encampment Resolutions and Officer Reports committee reported there were no actions to consider.
- 22. Commander Melcher requested to know which past department commanders planned to attend the 2016 National Encampment in Springfield, Illinois. Commander Melcher stated the incoming Department Commander would be attending in that status, and that he planned be attending in the status of PDC. Secretary Russ will be attending as a National Elective Officer, and PDC Lafferty stated he will be attending in his capacity as PDC.
- 23. Commander Melcher stated the Department of Kansas was presumed to be entitled to six delegates to the National Encampment. The actual number will be determined when the annual report is filed in April. Commander Melcher asked for nominations from the floor for the election of delegates to the 134th National Encampment. PDC Russ nominated the following to be delegates:
 - a. Shawn W. Bell, Camp 1
 - b. William E. Fischer, Jr., Camp 9
 - c. Conrad M. Fisher, Camp 16
 - d. K. Kirk Nystrom, Camp 16

- 24. The motion for election of delegates was seconded and approved. These brothers will be so indicated on the Form 49 submitted to National Headquarters.
- 25. Commander Melcher recognized PDC Russ, who moved, "All Members and Associates of the Department of Kansas who are in good standing as of this date (January 9, 2016) and are not otherwise entitled to membership at the 135th National Encampment nor elected as a "Delegate" to the 135th National Encampment shall be elected as 'ALTERNATE DELEGATES' to the 135th National Encampment of the Sons of Union Veterans of the Civil War, August 12-13, 2016, in Springfield, Illinois. A listing of those so elected as Alternate Delegates shall be included in the official proceedings of this encampment and shall be attached to the Department of Kansas Certificate of Election and Installation of Department Officers (SUVCW Form 49) and forwarded to the National Headquarters." Motion was seconded and passed.
- 26. Commander Melcher announced that, per the Department Bylaws, the 21st Annual Encampment of the Department of Kansas would be on January 14, 2017. Camp 4, Lawrence, indicated it was willing to host the encampment.
- 27. Commander Melcher called upon Treasurer Russ to present discussion on the proposed budget for 2016. Copies had been distributed to the members of the Encampment. This was for information purposes, as the Department Council will act on the budget at its post-Encampment meeting.
- 28. Commander Melcher stated the Department needed to establish the Department per capita for 2017. The current per capita is \$4.00. PCC Bill Fischer moved the Department per capita remain at \$4.00 for 2017. Motion was seconded and passed.
- 29. There being no more new business to come before the Encampment, Commander Melcher proceeded with the nominations and election of officers.
- 30. Commander Melcher reminded the encampment that the brothers recommended by the Nominating Committee had been placed into nomination for their respective positions. Those nominated were:

- 31. There were no motions from the floor to nominate any additional candidates, nominations were closed. In accordance with Roberts Rules of Order¹, candidates for a position which was not contested were declared by Commander Melcher as elected
- 32. Commander Melcher requested a motion from the floor to recognize and thank the Church of the Cross for providing the meeting facilities. Kirk Nystrom, Camp 16, moved for the request. The motion was seconded and carried.
- 33. Commander Melcher recognized Secretary Russ, who moved, "The proceedings of this encampment, upon approval by the voting members of the Department Council, and when signed by the outgoing Department Commander, shall be accepted as the official proceedings of the encampment, and be distributed to the camps of the Department." Motion was seconded and passed.
- 34. Commander Melcher presented the following awards to the indicated recipients:

OFFICER REPORTS TO THE TWENTIETH DEPARTMENT ENCAMPMENT

DEPARTMENT COMMANDER

For personal reasons which I will explain in person at the Encampment I am asking the Department to accept my request to pass the Commander's responsibilities in 2016 to Senior Vice Commander Mark Britton. I have been unable in 2015 to serve the Department as fully as I had hoped, and it appears that I will be unable to increase my effectiveness as Commander in 2016.

At the same time, I am proud of the work that the Department Vision Committee has done, and humbly ask the Department and our Camps to keep the Committee's vision at the forefront of our work together in the future.

In August, Camp Commanders and other officers received details of the Department Vision Committee's suggested pathways to achieving two purposes: 1) to enhance ways that our camps may educate our citizens, especially younger ones, about the causes and effects of the War of Rebellion, as well as the dedication of US soldiers, sailors, marines, and revenue cutter service in fighting for the Union; and 2) to recruit new, and especially younger, members who will carry on the purposes and objects of the Sons of Union Veterans.

The specific PATHWAYS FOR CAMPS are as follows:

- 1. Work with local school history teachers to develop programs to teach our youth about the Civil War:
- 2. Work with local JROTC programs and Boy Scouts to teach CW history;
- 3. Honor Civil War veterans by publicizing Camp events, meetings, and activities;
- 4. Set and/or dedicate headstones, with publicity provided to local media;
- 5. Schedule workdays to clean/reset existing headstones, with publicity to local media;
- 6. Alert local service and fraternal organizations, such as Rotary, Kiwanis, Lions, VFW, and American Legion that Camps have speakers available to present programs that tell the stories of their ancestors and explain the work of the SUVCW;
- 7. Publicize Camp Memorial Day observances with local media outlets;
- 8. Be visible in the community at every appropriate opportunity, by organizing camp color guards, by marching in local Memorial Day, Fourth of July and Veterans' Day parades, and by taking part in area Civil War days and other historical events;
- 9. Establish working relationships with other patriotic and veterans' organizations, such as VFW, American Legion, DAR, and others, and planning and organizing joint events with them (eg., Medal of Honor Remembrances);
- 10. Emphasize with our brothers the importance of telling friends and family the stories of their ancestors' service, impressing upon our brothers the imperative of passing on the mission of the SUVCW to younger generations;
- 11. Create a "Camp Bibliography" of members' favorite Civil War histories, biographies, novels, movies, etc, and post the bibliographies for the benefit of our brothers, especially new members. Share bibliographies with local media and libraries.

Pathways for the **DEPARTMENT OF KANSAS**:

- 1. Set a goal to establish new camps, by determining which communities hold promise for recruiting new members:
- 2. Reestablish the Department Guard, provide training for its members, and expand and enhance it with capable, dedicated leadership. Recruit new members for the purpose of serving as honor guards and firing teams at SUVCW observances around the State;
- 3. Strengthen education and patriotic instruction in the Department, and provide support for Camp Patriotic Instructors by sharing links to Civil War history websites;
- 4. Encourage greater participation in Department Encampments, and develop new Department leaders who will carry on the SUVCW mission in years to come.

It has been my honor to serve the Department as Commander in 2015, and I have especially appreciated the dedication of so many of our brothers, as well as the support they have given me as Commander.

I had the privilege of serving as Department Junior Vice Commander (JVC) in 2015 and enjoyed working with Commander Melcher, SVC Britton, and Sec'y Russ in furthering the work of the Department of Kansas. I received one membership application from National JVC Martin and forwarded the information to Old Abe Camp 16. The highlight of the year was organizing a new camp in Humboldt to bring Department representation back into SE Kansas. Even though the Civil War Sesquicentennial has passed, I believe that we are well positioned to continue to grow camps across the Department. Look for opportunities to speak about the SUVCW, its purpose, and how those interested can become involved.

My duties and related historical activities during 2015:

- 1. Elected SUVCW Department of Kansas Junior Vice Commander (January).
- 2. Served as Acting Chief of Interpretation & Resource Management for Fort Scott National Historic Site (NHS), overseeing staff and volunteers, program development, education activities for more than 2000 school children, living history, and museum operations, including events that related to the Civil War Sesquicentennial. (January thru September)
- 3. Notified Department of Missouri Dept of Transportation's proposal to change requirements for "traffic generator" signs which would have eliminated signage for non-fed/state historic sites. Proposal defeated due to public outcry. (January)
- 4. Notified Department of City of Richmond VA proposal to build minor-league baseball stadium on historic Shockoe Bottoms, site of the second largest slave market in the US. Proposal defeated due to public outcry. (January)
- 5. Gave presentation entitled, "Price's Raid Remembered," for the annual meeting of the Franklin County (KS) Historical Society, Ottawa. (January)

- 6. Notified Department of Chautauqua Amphitheater possible razing, site of GAR activities (February)
- 7. Gave presentation entitled, "The First Kansas Colored and the USCT in the Civil War," as part of Soldiers & Settlers: African Americans seeking freedom in the West, Topeka & Shawnee County Public Library (February)
- 8. Primary Department organizer for Humboldt Camp 9 (March)
- 9. Notified Department of National Trust's "Help Save the James" River campaign to prevent power lines being built across an undeveloped historic river landscape dating to colonial times (March)
- 10. Entry on "Fort Scott, Kansas" posted on Kansas City Public Library's *Civil War on the Western Frontier* historical website (March)
- 11. Notified Department of the April 11 interment of Maj Raphael Rombauer in Carthage MO (March)

PATRIOTIC INSTRUCTOR

With the 150th Anniversary of the end of the Civil War, there were many opportunities in 2015 for camps to provide month to month "What Happened Then?" presentations. One which was especially noteworthy was the Topeka Camp's reenactment of Lee's surrender to Grant, portrayed by Lane Smith and Randel Durban. It was so informative and interesting, they made us feel we were there! Definitely a high point of the year.

The anniversary of the assassination of President Lincoln in April of 1864 provided a topic which each camp would have observed. The flight of Booth, his capture and the shooting by Boston Corbett, who later became a doorkeeper in the Kansas Senate, showed again the many Kansas connections to the Civil War. The fall of the city of Richmond and Lincoln's peaceful entry into it, and the poignant reaction of the blacks of the city, pointing and shouting "There be Father Abraham, de great Emancipator," created drama that holds our attention to this day.

Our continued loss of real sons of Civil War veterans, including Col. John William Dinsmoor (Ret.) (the son of S.P. Dinsmoor of Lucas, Kansas) whose death late in 2013 was discussed in both 2014 and 2015. He was a decorated Vietnam Veteran, the only son of a Civil War veteran so honored.

The continued passing of World War II and Korean War veterans was often noted with sadness during 2015. It brought to mind stories of our own fathers and grandfathers who fought to bring freedom to an oppressed world.

"Stump the Experts" questions help to create interest in our history, such as the following.

- 1. "What paper money did Lincoln carry the day he died?" and
- 2. "Who was the third speaker at Gettysburg?" and

- 3. "What is the honor that is called "The Thanks of Congress?" (Answers:)
- 1. A Five Dollar Confederate Bill,
- 2. The Rev. Thomas Stockton, whose invocation brought tears to Lincoln's eyes,
- 3. A Resolution separate and distinct from the Medal of Honor, that was proclaimed over 30 times in the Civil War.

History comes alive when we remember it is a collection of true, magnificent stories.

Let us each keep the memory of past patriots alive by our words, deeds and patriotic instruction.

The 2015 controversy over the display of the Confederate flag, with the wise and careful response of the National Office of the Sons of Union Veterans, created lively discussion issues for our camps. This also opened the door for more discussions of battle flags of the Civil War and flags from our country's past.

At one camp meeting, a member unfurled a full-sized replica of George Washington's Battle flag, which he commissioned to fly over his private fleet of six ships. It is a white flag with a green Tree of Liberty, emblazoned with the cry: "AN APPEAL TO HEAVEN". Every petition and plea to King George had been rejected, yet a FINAL APPEAL could still be lodged. We may appeal to God Himself for Vindication of our cause! True then, True today! Submitted in F. C. & L.,

GRAVES REGISTRATION OFFICER

We continue to make progress in recording the burial locations of our Boys in Blue who eternally rest in the Sunflower State. As of 31 Dec 2015, there are 29655 Civil War veterans' Kansas gravesites listed in the national SUVCW Graves Database. This is an increase of almost 600 graves to the database since the beginning of the year. I have personally added about half, possibly more, of the increase but don't have an exact number since there has been a problem late in the year with my SUVCW Kansas Graves Administrator grave entry counter not increasing with each upload; it stands at 943 entries. Because of this issue, I have been adding gravesites via my personal SUVCW Graves user account, which, as of the same date, totals 3125 entries, 260 more than reported at the end of last year. I have also continued to add missing information, such as birth/death dates, enlistment/discharge dates, and Kansas GAR Post membership, to dozens of individual Kansas grave pages to provide a more complete record. I had the honor of participating in the headstone dedication ceremony for John Howard in Mount Hope Cemetery in Humboldt.

Camps continue to do good work in helping maintain Civil War veterans' graves with work days and genealogical research to obtain military headstones for unmarked graves. I urge Brothers to make this a priority for our camps. I apologize to those Brothers who have sought my assistance with grave and headstone matters but who have not received timely responses to queries. This year has found me time challenged due to personal and work priorities.

For the second year in a row, I offer special commendation to Sister Dorothy Reling of Cawker City KS, a member of LGAR Livermore Circle No. 66, who has researched and provided me with grave registration information on all known Civil War veterans interred in Osborne County KS. Huzzah, Sister Reling!

STANDING COMMITTEE REPORTS TO THE TWENTIETH DEPARTMENT ENCAMPMENT

BYLAWS COMMITTEE

The following amendments were submitted by the Department Secretary for consideration by the Department Bylaws Committee.

AMENDMENT 01

This change allows the re-establishment of a camp for department members-at-large. If established, the camp shall be designated as Col. John A. Martin Camp No. 8. This is the camp which was previously used for DMAL, and the charter for camp, although suspended by the department commander at the time, has not been revoked. If a DMAL camp is established under this section, it would need to request an EIN from the Department and would maintain a separate checking account.

CHAPTER III DEPARTMENT MEMBERS AT LARGE (DMAL).

Section A. AUTHORITY TO ESTABLISH.

In accordance with Chapter II, Article X, Section 1, National Regulations, the Department shall allow Department Members at Large (DMAL).

Section B. MUST FIRST BE ASSIGNED TO CAMP.

Brothers shall be assigned to the DMAL only after the application has first been processed as shown, below. No brother will be placed directly into the DMAL without having first been assigned to a camp for the remainder of the current membership year unless approved by the Department Commander.

Section C. OPPORTUNITY TO SELECT CAMP.

When applications are received from the National Organization for MAL, the Department Junior Vice Commander shall contact the brother and give him the opportunity to select one of the Camps in the Department to join.

Section D. GEOGRAPHIC ASSIGNMENT TO CAMP.

If the new MAL does not elect to choose a Camp, he shall be assigned to the Camp closest to his place of residence.

Section E. DEVELOPMENT OF GUIDELINES.

The Department Council shall develop guidelines for Camp assignment.

Section F. NO ESTABLISHMENT OF DMAL CAMP.

- 1. A separate camp shall not may be established for DMAL. When a DMAL camp has not been established, the The Department Secretary shall be responsible for the administrative requirements concerning brothers assigned to the DMAL.
 - 2. Designation of DMAL Camp. Said camp shall be designated as Col. John A. Martin Camp No. 8.
- 3. DMAL Camp Officers. When a DMAL camp has been established, the Department Commander shall appoint a Camp Commander and Camp Secretary/Treasurer for the camp. No other camp offices shall be required for the DMAL Camp. The appointed officers need not be assigned to the DMAL camp.
- 4. No brother may be assigned to the DMAL or DMAL camp if he holds membership in another camp or department.
- 5. The dues for the membership of the DMAL shall be set at the equivalent of the highest camp dues within the department as established by the annual camp reports submitted as of March 31 the previous year.

AMENDMENT 02

This amendment removes the requirement for a Fall Council Meeting to be held on the third Saturday of October. There will not be any required council meetings within the department unless specifically called for by the Department Commander with the consent of the council.

CHAPTER IV DEPARTMENT ENCAMPMENTS AND MEETINGS

Article II: OTHER MEETINGS

Section A. FALL COUNCIL MEETING.

The officers of the Department shall conduct the "Fall Council Meeting" each year on the **third Saturday of October**. The location and time for the meeting shall be determined by the Department Commander, with preference given to locating it at the camp which will be the host camp for the upcoming Department Encampment. If the meeting must be rescheduled, it should be held as soon as possible after the originally scheduled date.

- 1. Purpose. The Fall Council Meeting shall be for the purpose conducting the routine business of the Department, to include approving expenditures, policies, and procedures. The Department Council will not take actions which are reserved for the Department Encampment. Likewise, any action of the Department Council may be overruled by action of the next Department Encampment.
- 2. Voting Members. The elected offices of the Department and the immediate Past Department Commander are the voting members of the Department Council.

3. Non-voting Members.

- (a) All appointed Department Officers are members of the Council, without vote, and should be in attendance.
- (b) All brothers of the Department holding the honor of Past Department Commander are members without vote, and, as such, encouraged to attend the meeting.

4. Other Attendees.

- (a) Camp Commanders, or their designated representative, should attend. They should be prepared to report on the activities of their camp. This provides an opportunity for communication between the Department Officers and the camps. Camp Commanders or representatives are attendees without membership on the Council and without vote.
- (b) All brothers of the Department are permitted and encouraged to attend the meeting without voice or vote. Any attendee may request of the Department Commander to present an item to the meeting or to provide discussion or comments on an item being discussed at the meeting. It shall be the decision of the Department Commander as to whether this shall be permitted.

Article III II: ELECTRONIC BOARD ROOM

Section A. ESTABLISHMENT OF ELECTRONIC BOARD ROOM.

An electronic boardroom shall be established for the purpose of conducting the business of the Department between the Department Encampments and Council meeting.

Section B. PUBLISHED POLICY REQUIRED.

A Department policy shall be established for the Department Council to submit motions to the Department Commander through approved electronic means, to conduct discussion of such motions through electronic means, to allow the voting members of the Council to electronically cast votes, for the Department Commander to announce the results of the vote, and for the Department Secretary to officially publish the results to the camps in a timely manner.

CHAPTERV V DEPARTMENT OFFICERS AND COMMITTEES

Article II: DUTIES OF OFFICERS

Section F: COUNCIL.

The Department Council, immediately after its installation, shall meet and elect a Chairman and Secretary. It shall devise and recommend such measures as will enable the Department to meet all of its necessary expenditures, and shall audit the receipts, expenditures and books of account of the Department and make a report, thereof, to the Department Encampment. Any permanent vacancy in a Department elective office shall be filled for the remainder of the term by a Brother elected via majority vote of the Department Council. The Department Council shall also meet during the Fall for the purpose of auditing the records of the Department and discussing the state of the Department. This meeting shall normally be in October at a time and place determined by the Department Commander. The Department Council shall perform such other duties as described in National Regulations of the Order.

1. Help camps establish relationships with schools. Some of our camps actively seek interaction with K-12 students (primarily elementary grades) by setting up a civil war style campsite. Throughout the day, classes rotate through the camp for civil war history, campsite demonstrations, Q&A, etc.

REPORT ON 133RD NATIONAL ENCAMPMENT

The 134th National Encampment, commemorating the end of the Civil War Sesquicentennial, was appropriately held in Richmond, within the shadows of the Virginia Capitol, from August 20-23, 2015. It was hosted by the Department of the Chesapeake.

The Department of Kansas contingent consisted of PDC Roy Lafferty and Dept JVC Bill Fischer, with PDC Alan Russ attending as National Secretary.

Commander in Chief Tad Campbell recounted his year of service, noting that he had traveled more than 100,000 miles in his effort to fulfill his duty and to meet as many Brothers as possible. He also honored his wife, Rachelle, who was National President of the Auxiliary to the SUVCW, and his daughter, Emilia, for their sacrifices in allowing the CinC to crisscross the country many times. National SVC Eugene Mortorff, Department of the Chesapeake, was unanimously elected as the order's Commander in Chief for 2015-2016.

Due to repeated violations of National requirements and repeated failures to take corrective actions, the Department of Connecticut had its voting privileges revoked for the Encampment.

Two particularly notable issues taken up at the Encampment were:

- 1. The continuing efforts to work with the IRS to gain 501(c)3 status for the Order. The primary stumbling block appears to be that the percentage of charitable donations made through the national organization is lower than what the IRS deems necessary for gaining 501(c)3 status. To begin the process of increasing such donations, the Encampment voted in favor of making the SUVCW ROTC medal, certificate, and ribbon available without charge when an application form is properly completed and submitted. This change took effect on January 1, 2016. Now Department of Kansas camps must go forth and build relationships with ALL the ROTC and JROTC programs throughout the state to ensure that a deserving cadet in each program is presented with our award. This is a tremendous opportunity to grow the Order for future generations.
- 2. The Rituals and Ceremonies manual was revised to incorporate changes made at previous National Encampments, to ensure conformity with Constitution and Regulations guidelines, and to correct existing deficiencies. The new manual was approved and supersedes the previous edition. Brother Russ emailed a digital copy to department members soon after the Encampment.

Other points of interest include:

- 1. The newly-created Department of the Columbia, including the States of Oregon, Washington, Idaho, and Alaska, was recognized.
- 2. There was an effort by certain Brothers in the Department of Pennsylvania to have the Encampment authorize the splitting of the department into two separate departments. The argument made by those Brothers was soundly defeated as being out of order. This was perhaps the low point of an encampment of an Order founded on Fraternity, Charity, and Loyalty.

The 2016 SUVCW National Encampment will be held in Springfield, Illinois, from August 11-14. Please make plans to attend if at all possible since it is within a 500-mile drive from most Kansas camps.
