1. As required by Chapter II, Article III, Section 1 of the Regulations of the Sons of Union Veterans of the Civil War and by Article VI, Bylaws of the Department of Kansas, SUVCW, the Twenty-Sixh Annual Encampment of the Department of Kansas, was held on March 26, 2022, in Emporia, Kansas.
2. In the absence of Department Commander K. Kirk Nystrom, the Encampment was called to order at 9:58 AM by Senior Vice Department Commander Robert D. Boyd II. This followed the memorial service. The opening was conducted per the Ritual and Ceremonials of the Order.
3. SVDC Boyd appointed PDC Michael A. Todd to act as Department SVDC.
4. The Department Secretary called the roll of officers, and reported all officers present:

5. SVDC Boyd then appointed the following brothers for the encampment:

6. The Chaplain's prayer and the Pledge of Allegiance followed.
7. SVDC Boyd then declared the Twenty-Sixth Annual Encampment of the Department of Kansas, Sons of Union Veterans of the Civil War, to be open for the transaction of such business as may legally and properly come before it.
8. SVDC Boyd welcomed National Senior Vice Commander-in-Chief Bruce D. Frail, Department of Rhode Island, to the encampment. SVCinC Frail briefly addressed the encampment.
9. The Credentials report was presented, as brothers signed in as they arrived at the encampment. A quorum was declared to be present. Summary of attendance is shown below. Appendix A contains the listing of attendees and their status.

10. SVDC Boyd appointed PDC Alan L. Russ (Chairman), PDC Michael A. Todd, and PDC Roy A. Lafferty to the encampment bylaws committee.

11. SVDC Boyd appointed PCC Ryan L. Todd (Chairman), PCC William J. Stoker, and James Graves to the Encampment and Resolutions Committee.

12. SVDC Boyd informed the Encampment of “housekeeping rules” to be used during the meeting.

13. The Department Officer and camp reports were received, reviewed, and compiled prior to the encampment. The reports did not contain recommendations requiring action by the encampment.

14. Brother Halfman moved to accept the officers reports as submitted. Motion passed.

15. Brother Lafferty moved to accept the camp reports as submitted. Motion passed.

16. Secretary Russ noted for the encampment that none of the reports contained recommendations requiring action by the encampment.

17. Secretary Russ reported the correspondence which had been received has previously been distributed to all officers and camp secretaries.

18. PDC Michael Todd presented the report of the nominating committee. Nominations were to be officially entered later in the encampment.

19. SVDC Boyd then announced the Department awards and certificates on behalf of Commander Nystrom as SVCinC Frail presented them.

20. Secretary Russ, as chairman of the Department Bylaws Committee, presented the committee report, along with the recommendations of the committee. The proposed amendments were submitted to the encampment for vote. A two-thirds vote of approval for amendments 2022-01 through 2022-11 was received, with all amendments being adopted with the required two-thirds margin of votes cast.

21. Brother Walter Schley presented the report of the Department Council Members and declared the financial records had been reviewed by the council and appeared to be in order.

22. SVDC Boyd then took the encampment into new business.

23. SVDC Boyd addressed the encampment with regard to the 2022 National Encampment, to be held in Michigan, August 11 through 14. The business meeting is to be held on August 12 and 13. SVDC Boyd stated he plans to attend as Department Commander, if so elected. The following past department commanders stated their intention to attend: PDC Bartlow, PDC Lafferty, PDC Melcher, PDC Russ, PDC Schmidt, and PDC Todd.

24. SVDC Boyd called for nominations to elect delegates to the 2021 National Encampment.

25. PDC Schmidt moved the following brothers be elected as delegates to the National Encampment. Motion carried.

26. PDC Russ moved all remaining Brothers of the Department of Kansas in Good Standing at the time of this Encampment shall be elected as Alternates to the next annual National Encampment of the Sons of Union Veterans of the Civil War. Motion carried.

27. SVDC Boyd asked if any camps were willing to host the 2023 Department Encampment. PDC Melcher, on behalf of Camp 10 stated they wished to host the encampment on March 18, 2023, in Winfield, with a back-up date of March 25, 2023. PDC Schmidt moved Camp 10 be the host camp, with the encampment on March 18, 2023, with March 25, 2023, as a back-up date. Motion carried.

28. PDC Russ moved the department per diem for 2023 be set at \$5.00. Motion carried.

29. SVDC Boyd passed the gavel to acting SVDC Michael Todd who then chaired the proceedings as Brother Boyd made the following motion from the floor. Brother Boyd moved to allow \$480.00 toward Camp and National Fees of \$20.00 per application for the year of 2023 for applicants. The motion was seconded. After discussion, the vote was called. Motion failed.

30. PDC Schmidt moved that “all future issues of *The Sunflower Picket*, Department of Kansas, SUVCW, newsletter, will be reviewed by the elected officers (Commander, Sr. Vice Commander, Jr. Vice Commander, Secretary, Treasurer, and Council) of the Department of Kansas before it is released for distribution to the membership. This review is for accuracy, content, and professionalism. The newsletter is not for personal opinion, bias or inaccuracies. It is for

dissemination of relevant factual information to the Department members about items that can help inform and grow the Order in a positive way. Communications by the officers in *The Sunflower Picket* should be so stated as who from and be done as so stated above. If the Department is going to send it out to all members the latest email address list that the Department secretary has should be used. It can also be sent to the local camp secretaries for distribution if needed.”

Motion was seconded. After some discussion, Brother Halfman moved to amend the motion to add the following to the first sentence: “All future issues of *The Sunflower Picket*, Department of Kansas, SUVCW, newsletter, will be reviewed by the elected officers (Commander, Sr. Vice Commander, Jr. Vice Commander, Secretary, Treasurer, and Council) of the Department of Kansas **[requiring only the approval of any three]** before it is released for distribution to the membership.”

Motion to amend was seconded, and the motion to amend the original motion passed.

The motion, as amended, was then voted on with the amended motion passing.

31. Brother Stoker moved to extend a “thank you” to the Ladies of the Grand Army of the Republic for making lunch available to us. Motion passed.

32. SVDC Boyd proceeded with the nomination of officers. The following brothers were nominated for the indicated office.

35. PCC Stoker moved to thank the Emporia Senior Center for providing the meeting facilities. Motion carried.

36. PDC Bartlow moved to accept the proceedings of this encampment as approved when they have been approved by the Department Council. Motion carried.

37. There being no further business to come before the encampment, SVDC Boyd turned over the gavel to SVCinC Frail for the installation of officers.

## **DEPARTMENT COMMANDER OFFICER REPORTS**

### **Department Commander - K. Kirk Nystrom, PDC**

It has been my honor to serve as Department Commander for 2020 and 2021. My term is now ending.

Due to inclement weather in past years, not every camp could join us for our traditional January Encampments. This had been an on-going problem each year. The major reason for the January dates had been the hope and expectation that National Officers would be available to attend.

At the request of Senior Vice-Commander, Robert Boyd, and others, a committee was established to consider changes to the Department's annual encampment date. Much helpful discussion occurred. Committee members also obtained additional input from their own camps. After much discussion, it was proposed to move the Annual Encampments to late March, with the 2022 date being Saturday March 26. This was approved at the January 2021 Annual Encampment.

With great Joy, I was able to assist in the Chartering of a new Camp in May 2021. The Charter of the Pvt. John N. Eckes Camp, No. 10 was presented by myself and Department Secretary Alan Russ. The ceremony at the Cowley County Historical Museum in Winfield was well attended. It looks to be a very healthy camp, with brothers in attendance from a number of surrounding towns. They will meet monthly. They are being ably led by Camp Commander Kent M. Melcher, PDC, Senior Vice Camp Commander Joseph E. Chrisman, Junior Vice Camp Commander William K. Mueller and Secretary/Treasurer Eric L. Crittenden.

There was nothing covering the period between January 2019 and January 2021. Subsequent request failed to be productive. With the help of our National Executive Director, David Demmy, and our camp secretaries, I was able to generally reconstruct the department membership list, along with obtaining copies of the 2020 missing reports, etc. This process took many hours to accomplish, but it gave us the starting point for the 2021 Camp and Department Annual Reports.

### **Civil Wars Memorial Officer - Rocky D. Ansell**

The following is my report for the Department of Kansas SUVCW Memorials Officer.

On August 31 of last year I submitted an application for the position of Department of Kansas SUVCW Memorials Officer. On September 1, 2021 I received via email Department Order 6 advising my appointment to that position.

I have been working with the member of Humboldt Camp #9 regarding Civil War Veterans buried in the Evan Young Cemetery near Humboldt, Kansas. Two members of the Deal family, Sgt Daniel Deal and Pvt Martin VanBuren Deal, were interred at Evan Young Cemetery, and I've identified two additional civil war veterans with the possibility of more, at that cemetery. Unfortunately, some time in the past this cemetery was relinquished back to private ownership and is not readily accessible by the public. For several years members of Humboldt Camp #9 have been pursuing the possibility of erecting a monument recognizing members of the Deal family, and other civil war veterans from Humboldt, Kansas area, at the Mount Hope Cemetery at Humboldt. So far several plots have been identified as belonging to the GAR, which should allow Humboldt Camp #9 to utilize said plots for a suitable public monument in tribute to those civil war veterans we are able to identify. Work on this project continues.

Recently I was notified that a descendent of Charles W. Romp (Civil War soldier, Iowa 24<sup>th</sup> Volunteer Infantry, Union Army) was seeking assistance in obtaining a veterans grave stone. To date I have been unable to locate the Romp family plot at Fowler Cemetery in Neosho County, Kansas. This cemetery is in a rural part of the county and has fallen into a state of disrepair and so far records of which grave in the family plot belongs to Charles Romp have not been found. I continue to utilize the resources I can find so I can assist the family with getting a grave stone for their Civil War veteran.

### **CAMP REPORTS**

#### **Corp. Patrick Coyne Camp No. 1 – Commander James H. Graves, PCC**

The following is a short summary for the Cpl. P. Coyne Camp #1 in Wichita since our last report at the Department of Kansas Encampment meeting in January 2021.

The camp was unable to meet in person in January and February 2021 due to COVID-19 and the closing of our meeting location in that regard. Our first in-person meeting was held in March of 2021 and those have continued on our scheduled nights throughout the remainder of the year.

The camp has had an increase in membership in 2021 with 4 new members joining the ranks. They are all active in attending meetings on a regular basis which add to our attendance on the given meeting night.

After having completed the Highland Cemetery project in Wichita in Nov 2020 (after 11 years), to raise, straighten, and clean all the civil war veteran's headstones, we put together an agreement with Maple Grove Cemetery to do the same around the Pavilion starting in March of 2022. These 88 headstones surrounding the restored Pavilion. This will be an ongoing project for the camp. Workdays have been scheduled starting in March 2022.

The camp placed (3) wreaths in honor of Memorial Day. The locations were the Pavilion at Maple Grove Cemetery, the Soldiers and Sailors Monument in downtown Wichita, and the GAR plot at Highland Cemetery all in Wichita.

In October a small number of members attended the civil war monument re-dedication at the invitation of the Eckles Camp # 10 in Winfield.

In November the camp held elections for 2022 camp officers. These officers were installed by Past Department Commander Tom Schmidt with brother James Graves elected as Camp Commander succeeding brother Terry Justice who held the position for 3 years.

On December 18 the camp sponsored the Wreath's Across American Program at the GAR Pavilion at Maple Grove Cemetery in Wichita. The camp sold wreaths to be placed at the headstones surrounding the pavilion and participated in the ceremony. Brother Steve Hamlin coordinated the effort for the event. 85 wreaths were placed which covered all but 3 of the 88 headstones. The 3 needed wreaths were purchased on the day of the event so that all the headstones surrounding the pavilion were taken care of.

As part of its regular meeting format, using the prescribed ritual guidelines, a short program on a civil war topic is presented. These have been very interesting and informative. Programs range from member ancestor history, local cemetery information, GAR memorabilia and civil war engagements. Our meeting attendance seems to hold steady in the range of 8-14 attendees with the majority of meetings having double digit attendance.

### **Pvt. John N. Eckes Camp No. 10 – Commander Kent M. Melcher, PDC**

Private John N. Eckes Camp #10, Department of Kansas, is one year old, with a Date of Rank of February 25, 2021. Dealing with the restrictions of the pandemic made the chartering process difficult: our members held some meetings via ZOOM, which was less than ideal. However, the Camp made important decisions about when to meet and where. We also talked about the purpose of the SUVCW and adopted some Camp priorities. Throughout the process, Brother Alan Russ served as a guide with his wealth of knowledge of requirements for the formation of a new Camp. As the Camp organizer, I will always be indebted to Brother Russ for his counsel.

The most significant decision that our brothers made was to name the Camp after Private John N. Eckes, who served with Company E, 47th Ohio Volunteer Infantry. Private Eckes was honored with a Congressional Medal of Honor for his participation in action at Vicksburg on May 22, 1863. (See below.) Private Eckes is buried in Union-Graham Cemetery in Winfield.

In the past year, Eckes Camp #10 has conducted two rededications of Civil War monuments. The first, at the Oxford, Kansas, Cemetery, was assisted by an honor guard firing team, with taps, from the American Legion in Winfield. The second, at Riverview Cemetery in Arkansas City, Kansas, was assisted by an honor guard flag team consisting of the American Legion and VFW from Arkansas City, as well as by brothers of the Sons of the American Revolution in Wichita. Brother Jimmy Coyne fired three volleys from his Enfield rifle. The Cowley County Courier-Traveler newspaper ran stories in advance of both events, with photographs of the monuments. In Oxford, about ten people from Oxford and Winfield attended. Over thirty people attended in Arkansas City. Both events were planned in conjunction with the 150th Anniversary celebrations of the two communities.

The Camp manned information booths at Oxford and Arkansas City, as well as at an event in Sedan, Kansas. A few weeks after the Sedan event, we were invited to present a program for the Chautauqua County Historical Society. Brothers Eric Crittenden, Terry Justice, and I drove to Sedan to make the presentation. In the fall, I was asked to bring the address for the annual Wreaths Across America program at the Kansas Veterans Cemetery in Winfield. Over two hundred people attended that event.

This year, Camp priorities include holding regular monthly workdays at cemeteries in communities near Winfield. There are hundreds of stones to clean and some that need to be reset. The Camp is blessed to have as a charter member Brother Joe Chrisman, SVC, who is the Sexton of the city cemeteries in Winfield. He is providing expertise and guidance as we plan the cleaning and resetting work.

There are some unmarked Civil War veterans' burials in local cemeteries. Brother Terry Justice, PCC, is doing amazing work cataloguing the cemeteries to find those graves so that the Camp can work with the cemeteries' Sextons to order stones.

The Camp's current membership is sixteen, chartering with fifteen and initiating a new member at our February meeting. The Camp is blessed by what each of our brothers brings in dedication to the cause of "keeping green" in the memory of our citizens the sacrifices of those who fought to preserve the Union, 1861-1863.

Winfield has a long tradition of holding a Memorial Day observance at the Veterans Cemetery, which is planned by the local veterans' organizations. While we hope to be invited to be part of that observance, the Camp has also discussed conducting a ceremony at one of the several nearby cemeteries that do not have an observance.

Finally, there are several Civil War monuments in the area that the Camp plans to assess as to needed maintenance. That is a priority that may take a while for the Camp to undertake, as some of the monuments may require significant funding to complete.

Brothers, it is my privilege to serve as Commander of Eckes Camp #10. My thanks to all our brothers in the Department for your support as we have gotten started.

"The Forlorn Hope": General Ulysses S. Grant ordered an assault on the Confederate-held heights at Vicksburg, Mississippi. The plan called for an all volunteer storming party to build a bridge of "facines" across a deep ditch and plant scaling ladders against the 16-foot-high enemy embankment in advance of the main attack. The volunteers knew the odds were against survival and, in fact, in nineteenth century vernacular, the mission was labeled a "forlorn hope". Only single men were accepted as volunteers. Twice as many men as needed came forward, from which 150 were selected. The assault began in the early morning following a naval bombardment. Union soldiers came under enemy fire immediately and were pinned down in the ditch they were to cross. Despite repeated attacks by the main Union body, the men of the forlorn hope were unable to retreat until nightfall. Of the 150 men in the storming party, nearly half were killed. Seventy-nine survivors were awarded the Medal of Honor.

## **DEPARTMENT COMMITTEE AND OTHER REPORTS**

### **Department Bylaws Committee - Alan L. Russ, PDC, Chairman**

The Department Bylaws Committee was established under authority of Department Order No. 7 (series 2021-2022) as a special committee of the Department. Proposed amendments to the Department Bylaws were distributed to the committee members for their review. This was followed by a virtual meeting of the committee to decide and vote on what recommendations the committee would make to the Department Encampment. A summarized statement concerning these amendments follows, along with the committee recommendation. The full amendments are attached at the end of the reports.

**2022-01** This amendment establishes precisely who shall be responsible for payment of a charter fee for a new camp. Currently, the charter fee is paid to the Department, and it is up to the camp organizer to either pay the charter fee or take up collections to pay the fee.

**RECOMMENDATION: The committee recommends this amendment be adopted.**

**2022-02** This amendment changes the periods during which camp elections and installations of camp officers by referring directly to the National Regulations.

**RECOMMENDATION: The committee recommends this amendment be adopted.**

**2022-03** This amendment corrects outdated references in Chapter IV, Article I, Section B (3)

**RECOMMENDATION: The committee recommends this amendment be adopted.**

**2022-04** This amendment clarifies the use of Robert's Rules of Order Newly Revised within the Department and clarifies its relation to the other governing documents of our Order.

**RECOMMENDATION: The committee recommends this amendment be adopted.**

**2022-05** This amendment clarifies who shall set the location for a Department Encampment.

**RECOMMENDATION: The committee recommends this amendment be adopted.**

**2022-06** This amendment clarifies who comprises the Department Council. This does not change the make-up of the council, but fully describes the council membership. This amendment

eliminates the previous electronic board room, as Department Council meetings may be virtually held at the direction of the commander.

**RECOMMENDATION: The committee recommends this amendment be adopted.**

**2022-07** This amendment clarifies the maximum size for committees and adds the Department Commander as a member (ex officio).

**RECOMMENDATION: The committee recommends this amendment be adopted.**

**2022-08** This amendment adds the Department Bylaws Committee as a standing committee and defines its membership and how it is organized. This amendment also removes the appointment of a special Department Bylaws Committee in Chapter IX based upon the committee becoming a standing committee.

**RECOMMENDATION: The committee recommends this amendment be adopted.**

**2022-09** This amendment clarifies the payment of National Per Capita by dual brothers by changing the wording to stress the current regulations while still allowing for a change to the National Regulations.

**RECOMMENDATION: The committee recommends this amendment be adopted.**

**2022-10** This amendment rescinds the existing Chapter VIII, as it pertains to the Department of Kansas Guard. This chapter was added in 2010 in anticipation of establishment of an organized Department of Kansas Guard. The department guard has never been established.

**RECOMMENDATION: The committee recommends this amendment be adopted.**

**2022-11** This amendment adds requirements for the Department Bylaws to contain the signatures of the Department Commander, Department Secretary, and the Commander-in-Chief. Although this has been the practice in the Department of Kansas, it is now included based upon changes to the National Regulations which were approved by the 2021 National Encampment.

**RECOMMENDATION: The committee recommends this amendment be adopted.**

The Charter fee for a new Camp shall be as determined by National Regulations of the Order. The fee shall be paid ~~to~~ **by** the Department and shall accompany the application for permission to form a camp.

**CHAPTER II

**Article III. ELECTION AND INSTALLATION OF CAMP OFFICERS**

**Section A. ANNUAL ELECTION AND INSTALLATION OF CAMP OFFICERS.**

1. Camps shall hold annual elections ~~and installation~~ of officers ~~as follows:~~ in accordance with and during the period specified in National Regulations of the Order Chapter I, Article V, Sections 2 and 3.

2. All Past Commanders-in-Chief, Past Department Commanders, and the Department Counselor, shall be non-voting members of the Department Council. Non-voting members of the Department Council have full rights to attend all meetings and internet discussions of the Department Council (including while in executive session) and be recognized and heard on all issues before the Department Council. They shall not be counted for the purposes of establishing a quorum, nor shall they be able to make or second motions.

3. The Department Commander may invite other non-voting Brothers from whom he or the voting members wish to receive advice and counsel or information.

4. The Department Council shall have and shall exercise all powers of the Board of Directors, except in so far as such powers may be assigned to other persons in the National Regulations or Department of Kansas Bylaws.

This includes reviewing changes to the National Constitution and Regulations of the Order as passed by a National Encampment. The committee shall ensure all requirements in Chapter IX, Article III, are complied with concerning proposed amendments.

b. Membership. The chairman and members of the committee shall be appointed by the Department Commander.

**Article III. BYLAWS AMENDMENTS**

Such rank shall be awarded by the Department Council upon the recommendation of the Department Commander. A commanding officer may be appointed for a period of up to three (3) years. All such appointments shall be announced by Department Order.~~

### **~~Section B. FIRST SERGEANT.~~**

~~The commanding officer of the Department Guard shall have the authority to recommend the appointment of a senior non-commissioned officer with the rank of first sergeant. Such rank shall be awarded by the Department Council upon the recommendation of the Department Commander. A first sergeant may be appointed for a period of up to three (3) years. All such appointments shall be announced by Department Order.~~

### **~~Section C. COLOR BEARERS AND COLOR GUARDS.~~**

~~The commanding officer of the Department Guard shall have the authority to appoint necessary color bearers and color guards with ranks of corporal and sergeant. The commanding officer shall notify the Department Commander of any such appointments and shall request that the appropriate Department Order be published.~~

### **~~Section D. ROSTER.~~**

~~The commanding officer shall furnish the Department Secretary a current roster of the Department Guard annually or whenever any changes to the roster occur.~~

### **~~Section E. UNIFORMS.~~**

~~All members of the Department Guard shall wear appropriate Civil War era uniforms, accompanied by appropriate equipment, as directed by the commanding officer.~~

### **~~Section F. SUBORDINATE TO SONS OF VETERANS RESERVE (SVR).~~**

~~As required by the National Regulations of the Order, the Department Guard, when participating "where Camp Guard units, Department Guard units and SVR units are participating, the highest ranking SVR commissioned or non-commissioned officer shall have command of all military bodies of the SUVCW, regardless of the rank of an officer in a Camp Guard or Department Guard." (Chapter IV, Article I, Section I)~~

### **~~Section G. CAMP GUARDS SUBORDINATE TO DEPARTMENT GUARD.~~**

~~Any Camp Guard units, whether officially established or not, shall fall under the command and authority of the commanding officer, Department Guard, at any function or activity where the Department Guard is officially present.~~

4. Before becoming effective, all Bylaws and Bylaw amendments shall be approved by the Commander-in-Chief in writing.

5. The Department Commander shall sign the Department's Bylaws each time they are modified and forward them to the Department Secretary.

6. The Department Secretary shall sign the Department's Bylaws each time they are modified and forward them to the Commander-in-Chief for approval once they have been signed by the Department Commander.

7. The Department Secretary shall forward a copy of the Department's Bylaws signed by the Commander-in-Chief to the Executive Director each time they are modified and no later than 45 days after receiving the approved Department Bylaws from the Commander-in-Chief.
