

#### FROM THE DEPARTMENT COMMANDER

Brothers, I want you to know that the idea for the Brother Robert Dean Boyd, II, Membership Challenge was initiated by a unanimous vote of your Department Council. Brother Tom Schmidt recommended a membership drive as a 2025-26 objective. He suggested that we name the effort to honor our recently



departed PDC, who served in 2022-23 as Department Commander. It was my privilege and honor as Commander to issue Special Order No. 2 to muster the camps to action.

Growing our membership in the coming year will not only honor Brother Robert but will also provide an added reason for celebration at next year's Department Encampment. In 2026, we will celebrate the thirtieth anniversary of the reconstituting of the Department of Kansas. Think what it means when we record an increase of eighteen new members (three new members per Camp), or even more. It will be my pleasure to preside at that Encampment!

While our Camps always welcome new members with gratitude and gracious inclusion into our fraternity, we must recruit with intentionality if we are to strengthen the purposes and work of our order. As the proverb goes, "Many hands make light work." I will add that younger members increase longevity.

At next year's Encampment, I will be seventy-eight years old. For some time now I have become aware that our most active brothers seem to be of the "older generation." To keep our Department strong, we need to recruit the next generation of Sons (who are now mostly great-great, or even 3X great, grand-sons) of the Boys in Blue.

It also seems obvious that besides recruiting new members, we also need to bring younger brothers into Department roles. One of my objectives as incoming Commander was to ask new brothers to become active at the Department level. By "learning the ropes" they will, in time, transition into leadership positions. A favorite saying of mine, which I learned many years ago at a leadership event for pastors, is this, "The best leaders empower new leaders."

I know all of us want the PDC Robert Boyd, II, Membership Challenge to be a success. But how can we meet the challenge? I suggest that we commit to this saying in our minds: "The most effective recruitment is one person to another." That doesn't mean that we don't need to utilize

modern media to inform the public who we are and what we do as Sons. Facebook and other social media, simple ads in Memorial Day and Veterans' Day newspaper pages, and letters to the editor (be careful never to touch on politics or religion if you identify yourself as a SUVCW member) are all good ways to "go public".

But we must never lose sight of the fact that the most effective way to bring new brothers into the SUVCW is through personal contact and personal invitation into our fraternity. Some of us are pretty good at telling our stories spontaneously. Others, maybe not so much. So, here's another learning from my previous work in planting and developing new churches. It's called the "Elevator Speech", a thirty-second "window of opportunity", as if you are in an elevator.

For example, you may be wearing a shirt with a SUVCW logo, and someone asks simply what the logo means. In those few seconds you have their undivided attention. Develop and memorize a basic statement of who we are, where we come from, the important work that we do, and when and where we meet. Give them your "business card." Yes, that's right, get a few cards made, carry them with you, and point out the national SUVCW and Department website addresses on the card. Be ready to answer follow-up questions.

Finally, INVITE: "I hope you will consider becoming a member. If I can help in any way, my email address is on my card. I would love to hear from you."

So, brothers, the PDC Robert Dean Boyd, II, Membership Challenge is underway. Make it your personal challenge to recruit at least one new member this year.

The soldiers who served the Union could not realize the impact they were having on history. They could not envision the difference they were making on future world history and events. The line "One nation under God, indivisible, with liberty and justice for all" holds true meaning thanks to their actions.

We should be proud to be "Sons of Union Veterans of the Civil War" for we are the descendants of those who preserved this nation we enjoy today. And being members of the Department of Kansas holds special meaning as it was here, in the Lawrence area, where it all began 170 years ago during the Wakarusa War.

We should be recruiting potential new members at any opportunity. The camps are the life blood of our organization, and we need to have new people joining on a routine basis. Hopefully some of these new members will be regular attendees at camp meetings and camp activities. Make sure your camps are more than just a meeting. Whether its cemetery projects, involvement with the Eagle Scout certificate program, Memorial Day ceremonies, community events and parades or having an interesting speaker at some of your meetings that not only members want to hear but maybe the public as well. Make joining the SUVCW more than just an opportunity to attend a meeting. Camps must be active and involved in the community to keep them relevant. We offer something out of the ordinary. New members are a win-win for the camp and the department.

If a camp focuses on this recruitment challenge and puts a recruiting plan together, they will be successful. If a potential member is not sure about his Civil War lineage, they can join as an associate. We can then help them in researching their genealogy to try and find a Union Civil War ancestor to move their status to a lineage membership. If necessary, we can help with completion of the membership application. Camp secretaries should be up to speed with the requirements of the membership document, but we are here to help.

As I mentioned before, I made this camp recruitment challenge at the May 5 Department Council Meeting, and during discussion on the proposed plan I accepted a friendly amendment to name this proposal after the late Kansas Past Dept Commander Robert Boyd, and I accepted. In his memory, I encourage the camps to accomplish the goal of three new members for their camp. I look forward to recognizing your accomplishment of this challenge at our next Department Encampment.

Now that the flurry of collection of dues and the department encampment is over, things have quieted down to a dull roar (at least THAT part of my life) so there's not much to report, treasurer-wise anyway. However, I thought you might like a report on a recent trip down south.

As 2 Samuel 11 says in the Bible, "it was the spring of the year when kings go off to war" but there being no war for old men like me, my wife and I went to Dauphin Island in Mobile Bay, Alabama, to avoid the cold. It wasn't exactly Spring but that's how the story goes. In late February, on the way back, we were driving home along I-40 in Arkansas and stopped for fuel. While there I realized my ancestor, Corporal Samuel Jasper Hopper, served in the 1st Arkansas Infantry at Fort Smith and was buried somewhere in northwest Arkansas. I looked it up and, lo and behold, the exit to the highway leading up to his cemetery was the next one up the road! So, I asked the wife if it was ok and, getting permission, turned north. She said, "Is it far?". "Nah".

We then drove thirty tortuous miles on a road similar to the Million Dollar Highway north of Durango, Colorado. She said repeatedly, "are we about there?" "Just around the bend dear".


Well, we finally arrived at the little town of Aurora where he is buried and the GPS said, "turn left." Turn left was straight down into a valley but there was a road, thankfully paved, that wound down and across



the War Eagle River to a beautiful little cemetery set in a little green field along the river. We wandered around and eventually found his stone. I was dejected to find it falling over and almost unreadable. Having brought nothing with which to clean or reset it, I could only take a picture.

When I got home; however, I realized from a conversation with PDC Russ they would replace broken stones so I contacted the cemetery and they put me in touch with the Brashears Funeral Home who said they would gladly receive the stone and set it for me (for \$165 but I thought that was reasonable). I got the form and had the funeral home sign it (a little snail mail back and forth) and

submitted the form, a document showing the original stone placement in 1900, and a picture to the VA online site. I



didn't hear back for a few weeks and sent an email to ask them if they got it. They said they did and within a few days they replied that they would be sending a new stone to Arkansas!

I'm so glad I took the time and was pleased with the process. It was my first attempt at getting a stone and it was pretty painless. I'm looking forward to getting a picture (and a bill) after they

set the stone. I encourage all brothers to continue the work so the Boys in Blue aren't forgotten!

Sgt. Samuel J. Churchill Camp 4, Lawrence, Kansas held a workday at Maple Grove Cemetery at the northeast edge of Lawrence on Saturday, April 19. They received permission from the City of Lawrence to straighten and clean headstones of the Civil War veterans there. There are well over sixty Civil War veterans buried in the small cemetery.

Brother Dennis Lawrence had made a tripod with a winch for pulling the stones out of the ground so they could be reset. Brother Mike Todd brought the Wet and Forget product for cleaning. Brother Mike Hadl brought the donuts for nourishment. A number of the camp's brothers attended the event. They straightened double-digit numbers of the headstones and cleaned twelve to fifteen. They are planning another workday in July to try and complete the work at Maple Grove.

Brothers Tom Schmidt, John Shobe and Mike Hadl met with the head of maintenance at KU endowment the first part of May to talk about allowing the Lawrence camp to clean the headstones at Pioneer Cemetery in Lawrence. There are over twenty Civil War headstones on site with the majority of them have served in Wisconsin units. After the meeting the camp was given permission to do so, and this workday will be scheduled this year.

In February the camp held their monthly meeting at the Eldridge Hotel in downtown Lawrence. After a short business meeting, they were given an interesting tour of the historic hotel with details of famous people and events that

were involved at the site. Brother Chris Cardone of the Topeka camp came to the April meeting to talk about his children's book on the Civil War. At the camp's May meeting Brother John Shobe gave a presentation about his four Civil War ancestors. One is buried is in Oak Hill Cemetery at Lawrence, and another in Maple Grove cemetery at Lawrence.

The camp met at Oakhill cemetery on Saturday, May 24, to put out over 450 flags on the Civil War veterans' graves. With the help of a local 4-H group and some other volunteers the seven camp members who attended were able to accomplish the task of marking the many Civil War veteran's graves for another Memorial Day. # FROM THE ARCHIVES OF THE SUNFLOWER PICKET

#### Who Was William Washington Nixon?

Each year, the Department Commander presents the William W. Nixon Camp of the Year Award to a deserving camp of the Department. This award has been presented since 1997.

So, who was William Washington Nixon, and why is he important to us? Fortunately, Brother Blair Tarr of Old Abe Camp No. 16 researched him for us and submitted an article about him to the Summer 2004 issue of *The Sunflower Picket*. Here is that article.

# WILLIAM WASHINGTON NIXON Commander-in-Chief, Grand Army of the Republic 1940-1941

William Washington Nixon was the only Kansan to serve as the National Commander-in-Chief of the Grand Army of the Republic, having been elected to that post at the Seventy-fourth National Encampment at Springfield, Illinois in 1940.

He was born near Pittsburgh, Pennsylvania, the son of Samuel and Jane (Steele) Nixon. The day was Washington's Birthday, February 22, 1846, a fact that gave him his middle name. Because of his age, William did not enlist until January 30, 1864, as a private in Company I, 2nd Pennsylvania Heavy Artillery. He arrived in Grant's army just before Cold Harbor and served at Petersburg. Nixon was stationed at Farmville, Virginia, at the time of Lee's surrender, and was discharged at Philadelphia on January 29, 1866.

Nixon made one visit to Kansas before settling here for a lifetime. In the Spring of 1866, he and three other young veterans made their way by water from Pittsburgh, Pennsylvania, to Kansas City, then on to Topeka. But Nixon backtracked to Iowa where he remained until 1869, when he returned to Pennsylvania. There he married Sarah Hope at Mansfield, Pa., on July 20 of that year. The couple moved to Iowa, starting a family. They settled in Jewell County, Kansas in 1879, on a farm in northeast Buffalo Township – a son still farmed it at the time of Nixon's death in 1944.

Sarah Nixon died on April 1, 1884. William remarried on June 11, 1885, to Maria E. Jones at Bridgeville, Pa. She died in 1927. With both wives, he had a total of eight children. William retired to a home he purchased in Jewell in 1903.

His interest in the Grand Army of the Republic was very strong. He joined in 1880, a member of the S. R. Deach Post 58 of Jewell, Kansas. At its strongest, the Deach post had 154 members. Nixon would be their last member. He was the Commander of the Department of Kansas in 1934-35, and again in 1943. He attended encampments and reunions faithfully, including the 75th reunion at Gettysburg in 1938.

His election in 1940 meant that he would preside over the Seventy-Fifth National Encampment in 1941 at Columbus, Ohio. But his service would not end there. Longevity meant serving in other positions, and at the time of his death he was the National Judge Advocate General.

On the completion of his term as National Commander, a reception was held in his honor at the Memorial Building in Topeka, on April 5, 1941, as well as a parade and dinner at the Hotel Kansan. Martin Phillips, the commander of Capitol Post 1 of the American Legion, was master of ceremonies, while Mrs. Grace Wanner, the president of the

Woman's Relief Corps and secretary of the Grand Army of the Republic, both Department of Kansas, made the arrangements. Five other Kansas Civil War veterans were present: J.P. Fair of Mankato; W.E. Applegate and George Ellis of Topeka; Charles Wingrove of Clay Center; and A.T. Williams of Chapman. An address was delivered by the Honorable William A. Smith, a justice of the Kansas Supreme Court, who represented Governor Payne Ratner.

Among the gifts presented to Nixon was a copper plaque described as bearing his war record. This may be the plaque placed along his military gravestone, which actually commemorates his term as National Commander. He also received a silk lounging robe and an album containing prints of famous paintings.

William Washington Nixon died at his home in Jewell on March 17, 1944, at the age of 98. The services were held at the Methodist Church in Jewell. The American Legion presented a full military funeral at the Wallace Cemetery. The tributes summed up his life – farmer, banker, good neighbor, devout Christian, ideal father, kind friend, brave soldier, the patriot and patriarch of Jewell. He was the last soldier of Jewell County.

At the time of the 1941 reception he commented on what he thought about the war then raging in Europe. "There's nothing today that compares with the Union Army. It's just a machine fight now – a war of machines. They aren't doing any real fighting."

"I wish the world were at peace."

The above account is summarized from the Jewell County Republican, April 10, 1941 and March 23, 1944; the Topeka Capital, April 5, 1941; the Journal of the 62nd National Encampment of the Woman's Relief Corps, 1944; and the Proceedings of the 78th National Encampment of the Grand Army of the Republic, 1944.
